## Isbaddalka Qandaraaska WIC Formula Caanaha ee Minnesota, Oktoobar 2022

Laga bilaabo Oktoobar 1, 2022, qaacidada qandaraaska ee Minnesota WIC waxay ka beddelli doontaa alaabada Similac una beddelmi doontaa wax soo saarka Enfamil ee caanaha dhallaanka ku salaysan. **Caanaha dhallaanka ku salaysan soy, Similac Isomil ayaa ahaan doona caanaha qandaraaska.**

Qaar ka mid ah kuwa waaweyn ee Enfamil waxay cabbiri karaan iyo hababka Enfamil ee aan ka midka ahayn qandaraaska ayaa diyaar u ah ka qaybgalayaasha illaa December 2022. Wuxaan xaaladan si dhow ula soconaa Mead-Johnson, soo saaraha alaabada Enfamil, waxaan u cusboonaysiin doonaa iibiyeyaasha haddii wax maclumaad ahi isbedelaan.

Similac waxa uu haystaa qandaraaska WIC ee Minnesota ilaa Sebtembar 30, 2022, baddalka heshiiskaasna wuu sii socon doonaa in la oggolaado, si aad u sii wado baddalka qaababka Similac sida lagama maarmaanka ah illaa Sebtembar. Wixii ka dambeeyaa Oktoobar 1, Alaabta Enfamil mar dambe looma oggolaan doono baddalka caanaha Similac ee caanaha ku salaysan, sababtoo ah UPC-yada waxay hoos imanayaan qaybta cusub ee alaabta Enfamil, isku marna isku mar ma hoos iman karaan laba qaybood oo caano ah. Ka qaybgalayaasha waxaa lagula talinayaan inay iskaan-ku-baaraan caanaha UPC-yada ee My Minnesota WIC app si ay u go'aansadaan haddii qaacido gaar ah loogu oggolaaday kaarkooda WIC.

## Alaaboyinka Enfamil ee leh UPC-yada loogu talagalay Kala-guurka bisha Oktoobar

Maaddaama ka-baddalka Similac ee loo beddelayo alaabta caanaha ku salaysan ee Enfamil ay dhacdo bisha Oktoobar, fadlan hubi inaad kordhinayso kaydka alaabta Enfamil iyo hoos u dhaca saamiyada alaabta Similac. Waxaa laga yaabaa inaad rabto inaad ka hubiso alaab-qeybiyahaaga si aad u aragto haddii alaabta Enfamil loo tixgeliyo amar gaar ah oo sidaas darteed waxay qaadan kartaa waqtii dheer si aad u hesho kaydka dukaankaaga. Mead Johnson waxay bilaabi doontaa inay u dirto qaaciidooyinka Enfamil alaab-qeybiyeyaasha iyo qaybiyeyaasha Minnesota Ogosto 15keeda. Haddii aadan awoodin inaad xaqijiso Sebtembar 9-keeda inaad haysato caanaha Enfamil ee laga heli karo dukaankaaga Oktoobar 1deeda taariikhda kala-guurka, fadlan nagu soo ogeysii adigoo iimaylka ah [health.wicvendor@state.mn.us](mailto:health.wicvendor@state.mn.us) ugu dambayn Sibtambar 16keeda. Fadlan ku dar magacaaga qaybiyaha/qeybiyahaaga iyo xiriirkaaga iimaylka.

Qaababkan ayaa si toos ah u heli doona ka qaybgalayaasha sida ay hadda u ogol yihiin WIC waxay cabbiri karaan kaadhadhkooda WIC, sida baddalka qaababka Similac. Sababtoo ah cabbirradani way ka weyn yihiin, diiwaangelintu waxay ka jaraysaa laba ilaa saddex daasadaha cabbirka caadiga ah ee caanaha kaarka ka qaybqaataha mid kasta oo lagu iibsan karo cabbiradan. Wuxaad dalban kartaa alaabtan, haddii aadan awoodin inaad hesho sahay ku filan oo ah cabbirada WIC ay ogolaatay. **Cabbiradan weyn waxa kaliya oo loo ogolaan doonaa si ku meel gaar ah marka kala guurka uu dhaco ilaa December 2022.**

## **Bisha Oktoobar ee Kala-guurka - Alaabta Similac ayaa u hadhay qaar ka mid ah**

U gudubka alaabta caanaha ku salaysan ee Enfamil waxay noqon doontaa mid tartiib tartiib ah ilaa Oktoobar 2022, kaqeybgalayaashuna waxay heli doonaan faa'iidooyinka WIC oo ay ku jiraan caanaha Similac ku salaysan caanaha ama caanaha Enfamil ee caanaha ku salaysan.

- Ka qaybgalayaashu waxay heli doonaan dheefaha caanaha Similac bisha September waxayna haystaan 30 maalmood si ay u isticmaalaan dheefaha. Tani waxay u ogolaanaysaa ka qaybgalayaasha inay iibsadaan caanaha Similac ee caanaha ilaa toddobaadka afraad ee Oktoobar.
- Ka qaybgalayaasha la soo saaray caanaha laga bilaabo Oktoobar 1 waxay heli doonaan alaabada Enfamil.

Ilaa bisha Oktoobar, kaadhadhka ka qaybqaatayaasha qaarkood waxay liis-garayn doonaan caanaha Similac oo caano ku salaysan qaarna waxay qori doonaan caanaha Enfamil. Ka qaybqaatayaasha ay faa'iidooyinkoodu ku taxan yihiin caanaha Similac ku salaysan waxay sii wadi doonaan inay helaan baddalka, marka laga reebo badeecoo yinka caanaha ku salaysan ee Enfamil, maadaama aanay diyaar u ahayn Similac iyo Enfamil labadaba bixinta kaararka WIC.

Isbeddelada saamiyada ugu yar ee caanaha kaliya waxay dhaqan gelayaan 1da Oktoobar. Enfamil Infant, kaas oo bedeli doona Similac Advance ee shuruudaha saamiyada ugu yar ayaa ah shuruudaha kaydka ugu yar ee caanaha, si kastaba ha ahaatee haddii ka qaybqaataha uu

leeyahay qaacido ka duwan kaarkooda WIC, dukaamada ayaa la filaya inay dalbadaan caanaha, haddii si fudud loo helo iyada oo loo marayo silsiladda sahayda caadiga ah ee dukaanka. ## APL (Liiska Alaabta La Oggolaaday) Cusbooneysiinta iyadoo la filayo isbaddelka

**Waa muhiim in APL-yada dukaamada la cusboonaysiyo wakhtiga loogu talagalay isbeddelka caanaha Formula ee Oktoobar 1deeda. Haddii APL kaaga aan la cusboonaysiin, macaamiishaada WIC ma awoodi doonaan inay iibsadaan alaabta Enfamil ee lagu oggol yahay qandaraaska cusub.** Dukaamada isku dhafan, bixiyaha adeegga POS ama xafiiska shirkadda waa la ogeysiiyay isbeddelkan iyo inay aad muhiim ugu tahay in APL-yada dukaamada la cusboonaysiyo wakhtiga isbeddelka caanaha ee Oktoobar 1-deeda.

Dukaamada leh terminal-dambe, APL-yada sida caadiga ah si toos ah aya loo cusboonaysiyyaa oo waa inay la cusboonaysiyyaan APL-ka cusub Oktoobar 1.

## Isgaadhsiinta Ka-qaybgalayaasha ee Isbeddelka Foomamka caanaha

Ka qaybgalayaashu waxay haystaan oo ay sii wadaan inay helaan isgaarsiin ku saabsan isbeddelka qaacidada iyo kala-guurka. Waxaa lagu ogeysiyyay rugaha WIC ee deegaankooda waxayna ka heleen fariimo ku saabsan barnaamijka WIC ee My Minnesota oo ku saabsan isbeddelka caanaha. Waxay sii wadi doonaan helista fariimahan iyagoo filaya xilliga kala guurka. Minnesota WIC waxay si xoog leh ugu dhiirigelinaysaa ka qaybgalayaasha inay ku sawiraan caanaha UPC-yada abka si ay u hubiyaan in alaabta ay isku dayayaan inay iibsadaan ay ka heli karaan kaadhadhkooda WIC.

Xusuusin ahaan, qof kastaa wuu soo dejisan karaa abka My Minnesota WIC, laakiin si loo arko cuntooyinka WIC-la oggol yahay iyo caanaha ay heli karaan ka-qaybgalayaasha kaadhadhkooda WIC, **kaadhadhkooda waa in lagu diiwaangeliyaabka gudhiisa.**



## Xallinta dhibaatada Inta lagu jiro xilliga kala guurka

Haddii ka qaybqaataha uu isku dayayo in uu ku iibsado qaacido kaarkooda WIC, oo meesha diiwangelinta iibka aysan ogolayn, fadlan raac tillaabooyinkan:

1. Haddii ka qaybqaataha uu haysto ama uu awoodo inuu soo dejijo barnaamijka My Minnesota WIC oo uu kaarkiisa ku diiwaangeliyo app-ka, waxay iskaan karaan UPC-gasacadaa caanaha si ay u go'aamiyaan inay tahay qaabka saxda ah ee kaarkooda.
2. Haddii ka qaybqaataha uusan haysan ama uusan heli karin barnaamijka My Minnesota WIC, ku daabac weydiinta dheelitirka diiwaankaaga si aad u aragto caanaha ku yaal kaarka oo diyaar u ah iib. Haddii aadan hubin sida loo daabaco weydiinta hadhaaga diiwaankaaga, la xiriir adeeg bixiyahaaga. Fadlan ogow in bisha Oktoobar, ka qaybgalayaashu ay awood u yeelan doonaan inay helaan cabbirro waaweyn oo alaabada Enfamil ah oo laga yaabo inaan lagu qorin kaadhadhkooda beddelka cabbirka heerka WIC-la oggolaaday.
3. Haddii goobta diiwangelinta iibka aysan wali oggolaan qaacidahaa, iyo nooca caanaha lagu caddeeyey kaarka WIC, ka hubi adeeg bixiyahaaga ama xafiiska shirkadda si aad u hubiso inaad haysato nooca la cusboonaysiiyay ee Liiska

Alaabta La Ansixiyay ( APL) ee nidaamka diiwaangelintaada. Haddii aad leedahay terminal dhinac- taagan, gacanta ku cusboonaysii APL adiga oo raacaya tilmaamahan: Tilmaamaha Xaqijinta Faylka APL. [APL File Verification Instructions](#).

4. Haddii aad hubisay dheelitirka oo aad xaqijisatay nooca caanaha ee kaarka ka qaybqaataha, oo aad xaqijisatay in APL-kaagu uu casri yahay, fadlan iimayl u dir [health.wicvendor@state.mn.us](mailto:health.wicvendor@state.mn.us). Sanduuqan emailka ah waxaa sida caadiga ah lala socdaa saacadaha shaqada ee caadiga ah maalmaha shaqada, laakiin waxaa lala socon doonaa 7am-8pm Sabtida, Oktoobar 1deeda si looga jawaabo loona baaro arrimaha la soo diro. **Fadlan hayso afarta nambar ee ugu dambeeyaa ee kaarka WIC iyo UPC Qaabka loo isticmaalo ka qaybqaataha ayaa isku dayaya inuu iibsado, taariikhda iyo wakhtiga ka qaybqaataha uu soo gaday, iyo magaca dukaanka. Ku soo gudbi macluumaadkan iimaylkaaga.**
  
5. Haddii nidaamka iibkaagu aanu ogolayn caanaha Formula, waxa laga yaabaa inay tahay sababta oo ah APL waa cusub tahay, laakiin nidaamka diiwaankaagu wali ma soo dejisan APL (habkaani wuxuu qaadan karaa maalin ama laba maalmood waxaana bilaabay adiga adeeg bixiye). Waxaa laga yaabaa inaadan siin karin qaacidada ka qaybgalayaasha maalintaas, ka qaybqaatahana waxaa laga yaabaa inuu u baahdo inuu soo laabto marka nidaamka diiwangelinta uu soo dejijo APL-ka hadda jira. Wuxaan waydiisanaynaa dukaamada iyo ka qaybgalayaasha fadlan samir ha yeeshaan inta lagu jiro kala-guurka caanaha Formula, maadaama aan ognahay in arrimo aan la filayn ay soo bixi karaan.
