

Minnesota Cov Kev Cai rau Cov Neeg uas Muaj Kev Raug Tu Los Ntawm Cov Kws Tu Tib Neeg Uas Tsis Tas Muaj Ntawv Tso Cai Tu Tib Neeg (Minnesota Bill of Rights for Clients of Home Care Providers Exempted from Licensure)

Qhia Txog Cov Kev Cai (Statement of Rights)

Tus neeg mob uas tau txais kev pab hauv tsev uas nyob hauv lub zej zo muaj cov kev cai no:

1. Tau txais cov xov uas sau tuaj, siv cov lus yooj yim, hais txog cov kev cai ua ntej tau txais kev pab, nrog rau saib yuav ua li cas yog muaj kev yuam cai.
2. Txais kev kho thiab kev pab kom tsim nyog thiab raws nraim txoj kev npaj kho, thiab tos kom txais cov kev kho mob, raws li txoj cai ntawm kws kho mob los yog cov neeg pab kws kho mob thiab tus neeg raug tu, yog xav koom tes nrog txoj kev tsim tshiab, txhim kho, thiab soj txoj kev npaj kho thiab kev pab.
3. Yuav tsum qhia ua ntej tau txais cov kev pab no thiab kev nplua cov neeg ua hauj lwm uas yuav los pab, seb teem hais tias yuav tuaj pab heev npaum li cas, lwm cov kev xaiv kuj muaj los hais txog kev tu neeg hauv tsev, thiab qee hom kev nplua yog tsis kam pab.
4. Yuav tsum qhia ua ntej muaj kev pom zoo hloov los ntawm tus tu neeg txog kev npaj pab thiab yuav koom tes nrog cov kev txiav txim txog cov kev hloov txog cov kev npaj pab.
5. Tsis kam tau txais kev pab los yog kev kho.
6. Kom paub, ua ntej txais cov kev pab los yog thaum thawj zaug tuaj kuaj, saim puas muaj kev txwv txiav cov kev pab los ntawm tus neeg tu tib neeg.
7. Yuav tsum qhia, ua ntej kev kho uas yus tus neeg tu seb nqi npaum li cas rau cov kev pab ntawv; saib daim ntawv kho mob yuav them li ca, cov kev pab los yog lwm txoj kev pab nrog rau Medicare thiab Medicaid, los yog lwm cov kev pab los ntawm Tsoom Fww cov nyiaj los yog Tsoom Fww cov kev pab uas tus neeg tu tib neeg paub, yog hais tias paub; tus neeg mob yuav tsum tau them npaum li cas.
8. Kom paub hais tias muaj lwm hom kev pab nyob hauv zej zos, nrog rau lwm cov kev pab tu neeg hauv tsev thiab tu neeg, thiab kom paub mus nrhiav cov xov tseem ceeb txog cov kev pab no.
9. Muaj kev xaiv ywj pheej hlo txog cov neeg tu thiab hloov cov neeg tu neeg tom qab pib txais kev kho pib, raws li cov ntawv kho mob, kev tu neeg ntev, ntawv kho mob los yog lawm cov kev kho mob, los yog lwm cov kev pab rau pej xeem.
10. Ceev cov ntawv tseem ceeb, nyiaj txiag, thiab ntawv kho mob kom tsis pub lwm tus paub, thiab qhia cov kev cai ntawm tus neeg tu neeg thiab cov txheej txheem txog kev yuav nthuav cov xov tseem tseeb ntawv.
11. Mus saib tus neeg mob cov ntawv kho mob thiab sau cov xov tseem ceeb los ntawm cov ntawv kho mob raws li tsab cai Minnesota Health Records Act, Minnesota Statutes, Section 144.291 to 144.298.
12. Raug tu los ntawm cov neeg uas muaj kev kawm thiab yeej paub ua lawv cov dej num.
13. Kom muaj kev saib taus thuab nav thwm, thiab kom saib tau tus neeg mob cov khoom vaj khoom tsev.
14. Kom tsis txhob muaj kev cem, tsim hlwb, quab yuam thiab raug ntaus, nrog rau kev raug mob los ntawm yam tsis paub, kev tsis saib xyuas, nyiag nyiaj/nyiag khoom vaj khoom tsev, thiab txhua hom kev raug tsim txom uas ntaus nqi raws li tsab cai Vulnerable Adults Act thiab tsab cai Maltreatment of Minors Act.

15. Yuav tsum ceeb toom, kom tsim nyog ntawm kev hloov ntawm cov kev pab los yog cov nqi.
16. Kom paub txog tus neeg tu kuv rhuav tshem kev pab.
17. Tsawg kag mas yuav tsum ceeb toom kaum hnub ua ntej rhuav tshem txoj kev pab tu neeg hauv tsev. Nqe lus no tsis muaj feem rau cov teeb meem uas:
 - Tus neeg mob tus yam ntxwv cuam tshuam cov lus ntawm kev npaj tun rog rau lub koos haum tu neeg.
 - Tus neeg mob, tus neeg nrog tus neeg mob nyob, los yog lwm tus neeg tsim kev ua hauj lwm muaj kev puas tsuaj thaib tsis nyab xeeb rau tus neeg tu neeg hauv tsev.
 - Kev kub los yog muaj kev hloov ntawm tus neeg mob uas rau kev pab nyhav tshaj li kev npaj kho thiab yuav tut sis tau yam muaj kev nyab xeeb los ntawm lub koos haum tu neeg.
18. Muaj kev teem ntawm kev hloov thaum muaj kev txawv txav txog kev pab.
19. Nroo rau cov neeg ua hauj lwm thiab lwm tus txog tus neeg mob txoj kev xaiv txog kev pab, kev kho los yog tu, los yog tsis tu, thiab saib tsis taus los nav thwm tsis neeg mob los yog tus neeg mob cov khoom thiab txoj cai pom zoo kom hloov cov kev cai thiab kev pab, yam tsis muaj kev pauj kev ntxim siab, nrog rau txoj kev hem yuav rhuav tshem kev pab.
20. Paub txog seb yuav tiv tauj leej twg uas muaj feem cuam nrog rau koos haum tu neeg uas muaj kev lav phij xaub los daws cov teeb meem thiab kom muaj kev tshawb fawb txog koos haum tu neeg thiab sim mus daws qhov teb meem.
21. Paub txog lub npe thiab qhov chaw nyob thiab xov tooj ntawm lub xeev los yog zej zog mus tiv tauj kom tua xov tseem ceeb ntxiv los yog kev pab.
22. Qhia cov kev cai no yam tsim ntsej tim muag, los yog qhia rau tus neeg mob tus neeg sawv cev lso yog tus tib neeg sawv cev rau tus neeg mob, yam tsis muaj kev pauj kev ntsim siab.
23. Muab ib lub cav fais fab tauj rau hauv tus neeg mob los cov neeg lub tsev kom ua raws li lub xeev txoj cai.

Koj kuj xaiv los sab laj txog txoj kev txhawj xeeb nrog tus neeg tu koj. Rov qhia dua, cov tu neeg yuav tsum ua hauj lwm koj raws li koj txoj cai thiab yuav tsum ua raws li txoj cai. Thaim twg cov tu neeg yuav cov kev cai rau ntu no, lawv yuav raug nplua thiab muaj teeb meem txog kev tso cai.

Cov tu neg yuav tsum ua kom raws li cov hauv qab no:

- Txhawb thiab pab kom tsim nyog kom ua raws li cov kev cai no.
- Qhiav cov npe thiab cov tooj ntawm cov tib neeg los yog koos haum uas sawv cev thiab pab txog kev cai li choj rau cov neeg mob thiab cov pej xeem uas xav siv lawv cov kev cai.
- Ua txhua yam kom los pab cov neeg mob los thiab cov neeg nrgo lawv nyob kom muab tau cov xov tseem ceeb saib yog Medicare, medical assistance, lwm yam kev pab kho mob, los yog tsoom fwv cov kev pab uas los them cov nqi no.
- Pab ua kom cov neeg uas hais tsis tau lus kom muaj kev pab tau, los yog cov uas hais lwm hom lus dhau li lus Meskas.

- Nthuav txhua cov xov tseem ceeb thiab cov lus ceeb toom yam siv cov lus thiab cov nqe lus kom tus neg mob thiab neeg nyob hauv tsev muaj kev to taub.

Txwv tsis pub cov tu neeg kom los yog thov kom tus neeg mob los yog tus neeg nrog lawv nyob xuam tsis hais txoj cai twg uas teev tseg rau ntu no tsis lub sij hawm twg los yog lub laj thawj twg, nrog rau cov nqe lus pib kev pab los yog mus kos np emus nyob tsev laus.

Kev Txhais thiab Siv Cov Kev Cai

Cov kev cai no tsim kom muaj txiaj ntsim rau cov neeg mob uas tau txais kev tu neeg hauv tsev. **Txhua tus neeg tu neeg hauv tsev yuav tsum ua kom raws li cov kev cai ntawm ntu 144A.471, yuav tsum ua raws li ntu kev cai no.** Tus neeg tswj yuav tsum siv cov kev cai no. Tus tu neeg tsis muaj cai thov kom tus neeg mob tsis siv cov kev cai no vim tau txais cov kev pab no. Tus tu neeg huv tsev yuav txwv tsis pub kom tus neeb xuam nws cov kev cai es mam li pab nws. Nqe lus no tsis yog hloov los yog txo lwm txoj kev cai thiab kev ywj pheej uas tshwm sim vim tau txais kev tu neeg hauv tsev, tus neeg tu neeg hauv tsev, los yog tus tu neeg uas muaj ntawv tso cai raws li ntu 144A.43 mus txog 144A.482.
