Notes about copies of documents related to birth and death records

- 1) Documents related to birth and death records include: Recognition of Parentage (ROP), husband's non-paternity statement, affidavits of disclosure and nondisclosure regarding the release of original birth record information after an adoption, affidavits to retain parental rights, and affidavits and applications to amend birth or death certificates.
- 2) The requester is not charged a fee for an affidavit of disclosure regarding the release of original birth record information after an adoption because the requester does not get a copy of the document. The requester receives the information that can be released from the original birth record or a non-certified copy of the original birth record, which results in a \$13 fee.
- 3) The requester does not receive a copy of the affidavit of nondisclosure regarding the release of original birth record information after an adoption. A letter stating that the birth record information cannot be released is sent to the requester. A similar letter is sent if there is no affidavit found.
