## **Bayaanka Xuquuqda**

2. Xaq u leeahay in la siiyo daryeelka iyo iyo adeegyada ayadoo la tixraacayo qorshe ku habboon oo casri ah, iyo waafaqaya xeerarka daryeelka caafimaadka, heerarka daawaynta iyo daryeelka, iyo qayb libaax ka qaadatid dhisidda, habaynta, iyo qiimeynta qorshaha iyo adeegyada.
3. Xaq u leeyahay in loo sii sheego kahor inta aan adeegyada la siin, nooca iyo aqlaaqda shaqaalaha adeegyada siin doona, tirada booqashooyinka la soo jeediyay in lagu siiyo, doorashooyinka ee loo diyaarshay in ay wax ka qabtaan baahiyada daryeelka guriga, iyo saamaynta ay yeelan karaan marka adeegyadaan la diido.
4. Xaq u leeyahay in si horraansho ah loogu sheego in talooyin kastoo isbaddallada ee uu daryeelaha soo jeediyay ee qorshaha adeegyada ku jira iyo in aad qayb libaax ka qaadatid go'aan kasta ee isbaddallada qorshaha adeegyada ku taxluqa.
5. Xaq u leeyahay in uu adeegyada ama daawaynta diido.
6. Xaq u leeyahay in uu ogaado, kahor inta aan adeegyada lagu siin ama inta wareysiga booqashada u horreysa lagu jiro, caddadka ay noqonayaan adeegyada ka jira guriga daryeelaha.
7. Xaq u leeyahay in loo sheego kahor inta aan aadeegyada la bilaabin kharashyada uu daryeelaha adeegyada ku soo dallacayo; illaa inta ay tahay lacagta ay bixin doonaan caymiska caafimaadka, barnaamijyada guud, ilaha kale, haddii la yaqaanno; iyo kharashka rukunka laga rabo in uu jeebkiisa ka bixinayo.
8. Xaq u leeyahay in uu ogaado in ay dhici karto in ay jaalliyadda ka jiraan adeegyo kale, ay ka midyihiin adeegyada daryeelka guriga iyo daryeelayaal kale, iyo uu ogado meesha aad macluumaadka adeegyadaan ku taxluqa laga raadinayo.
9. Xaq u leeyahay in uu si xor ah u kala xusho daryeelayaasha jira iyo daryeelayaasha baddasho kaddib marka ay adeegyada bilawdaan, ka bixin xuduuddada caymiska caafimaadka, caymiska daryeelka muddada dheer, gargaarka caafimaadka, iyo barnaamijyada kale ee caafimaadka.



10. Xaq u leeyahay macluumaadka shakhsiyeed, maaliyadda, caafimaadka gaarka kuu ah la asturo, iyo in loo sii sheego sida ay yihiin daryeelaha qawaaniintiisa iyo habraacyada la xariira siidaynta macluumaadkaa.

11. Xaq u leeyahay in uu daabacdo macluumaadka rukunka u gaarka si waafaqsan qaybaha 144.291 illaa 144.298.

12. Xaq u leeyahay in uu adeegyada ka helo dad tababar fiican iyo tayo leh in ay hawshooda gutaan.

13. Xaq u leeyahay in la xushmeeyo iyo la xaqdhawro, in rukunka waxiisa la xaqdhawro.

14. Xaq u leeyahay in uu xor ka ahaado xadgudubka jirka iyo qaylada, dayaca, iyo guud ahaan nooc walba ee darxumayn ee ku xusan Sharciga Dadka Waaweyn ee Baylahan iyo Sharciga Darxumeynta Caruurta.

15. Xaq u leeyahay in si cagligala, lagugu sii ogeysiyo isbadallada ku soo fool leh adeegyada iyo kharashyada.

16. Xaq u leeyahay in uu ogaado daryeelaha sababtiisaa ah in uu adeegyada kaa joojinayo.

17. Xaq u leeyahay in la siiyo toban cisho oo ogaysiisa in adeegyada uu daryeelaha joojinayo marka laga reebo xaalado sida:

(i) Rukunka uu la yimaado dhaqamo si weyn u baddalaya qawaaniinta qorshaha adeegyada lala galay daryeelaha guriga xanaanada;

(ii) Rukunka, qofka rukunka la deggan, ama qof kale uu la soo baxo dhaqan xadgudub ah ama halis ku ah jawiga qofka adeegyada daryeelka bixinaya; ama

(iii) Xaalad degdeg ah ama isbaddal weyn ee rukunka xaaladdiisa ay sababayso in la bixiyo adeegyo uusan qorshaha hadda jira lagabixin karin iyo in uusan daryeelaha guriga daryeelka ku qancin karin.

18. Xaq u leeyahay wadashaqayn xagga wareejinta marka ay dhacdo in uu isbaddal ka dhaco adeegyada uu daryeelaha bixin doono.

19. Xaq u leeyahay in uu ka dacwodo waxa adeegyada lagu siinayo ku taxluqa, ama lagugu siin waayay, iyo xushmad-la'aanta iyo xaqdhawrid-la'aanta ee rukunka nafsaddiisa ama hantidiisa soo foodsartay.

20. Xaq u leeyahay in uu ogaado sida loola xariirayo shakhsi la shaqeeya daryeelaha guriga daryeelka ee masuul ka ah xallinta mushkiladaha iyo in uu daryeelaha uu xil iska saaro in uu baaro iyo iskudayo in uu aanada ama cabashad xalliyo.

21. Xaq u leeyahay in uu ogaado magaca iyo cinwaanka ee hay'adda gobolka ama degmada si aad ugula xariirtid macluumaad ama gargaar dheeraad ah.

22. Xaq u leeyahay in uu shakhsi ahaan xuquuqyadaan ku adkaysado, ama uu ku adkaysto rukunka wakiilkiisa ama qof un rukunka metelaya, ay aargosashada ka reebantahay.

Qaybhoosaadka 2. **Fasiraadda iyo adkaynta xuquuqda.** Xuquuqdaan waxaa loo dhisay maslaxadda rukumada ee la siinayo adeegyada daryeelka guriga. **Daryeelayaasha daryeelka guirga oo idil ay ku jiraan kuwa ka reeban ee hoosimaanaya qaybta 144.471, waa in ay addeecaan qaybtaan.** Maamulaha waxa uu adkayn doonaa qaybtaan iyo shuruuda daryeelayasha xuquuqda guriga daryeelka ee ka reeban shatiyaynt ee iskusi ugu dhigma guri shatiga haysta. Daryeelaha guriga daryeelka kama uu codsan karo ama amri karo qofka in uu ka tanasulo mid kasta ee ka mid xuquuqdaan ee shuruud looga dhigayo helitaanka adeegyada. Qaraarkaan xuquuqda ma uu baddalayo ama hoos uma uu dhigayo xuquuqda iyo madax bannanida kale ee ka jira meesha ay rukumada adeegyada daryeelka guriga ka helayaan, dadka bixinaya adeegyada daryeelka guriga, ama daryeelayaasha shatiga leh ee hoosimaanaya qaybaha 144A.43 illaa 144A.482.

Xeerarka MN, qaybta 144A.442 **Rukunka Guriga Lagu Daryeelayo; Jarista Adeegyada.**

Haddii daryeelaha guriga daryeelka nidaamsan, sida ay ku qeexentahay qaybta 144D.01, qaybhoosaadka 2a, oo haddana ahayn mid aqoonsiga Medicare haysta uu joojiyo heshiiska adeegyada ama qorshaha adeegyada ee rukunka guriga lagu daryeelayo, sida ay ku qeexantahay qaybta 144G.01, qaybhoosaadka 3, daryeelaha guriga daryeelka waa in uu rukunka guriga lagu daryeelayo iyo wakiilkiisa sharciga ama loo magacaabay rukunka, haddi uu mid jiro, siiyo ogaysiis qoraal ah ee jarista ee la soo raacinayo macluumaadka soo socda:

- (1) taariikhda rasmiga ah ee joojinta hirgalayso;
- (2) sababta loo jaray;
- (3) ayadoon la sii kordhin xilliga jarista, bixin cad ee qancinaysa rukunka guriga lagu daryeelayo ama walkiilka rasmiga ee rukunka wax aan ka badanayn toban cisho ee la shaqeeyo ee ogaysiiska taariikhda jarista si looga wadahadlo jarista;
- (4) cidda lagala xariirayo muddo caqligae gudaheeda tirada guryaha daryeelka ee daryeelayale kale ee aan sidaasi uga fogeyn guriga rukunka lagu daryeelayo, sida uu qorayo Xeerka Minnesota, qaybta 4668.0050 (Minnesota Rules, part 4668.0050);
- (5) qaraar uu daryeeluhu kaga qaybqaadan doono ee si nidaamsan daryeelka rukunka lagu wareejinayo daryeele kale ama daryeel-bixiye, sida ay qorayso qaybta 144A.44, qaybhoosaadka 1, tuducda (17);
- (6) magaca iyo macluumaadka qofka ah wakiilka daryeelaha guriga daryeelka kaaso uu rukunka kala hadlayo ogaysiiska jarista adeegyada;
- (7) koobiga bayaanka xuquuqda guriga daryeelka; iyo
- (8) qaraarka ah ogaysiiska jarista adeegyada daryeelka guriga ee daryeelaha guriga daryeelka ka imaanaya ma uu noqonayo ogaysiiska jarista guriyeynta lala leeyahay qandaraaska adeegyada guriyeynta leh dhisidda adeegyada.
