# LICENSING SURVEY FORM

Registered nurses from the Minnesota Department of Health (MDH) use this Licensing Survey Form during on-site visits to evaluate the care provided by Assisted Living home care providers (ALHCP). ALHCP licensees may also use this form to monitor the quality of services provided to clients at any time. Licensees may use their completed Licensing Survey Form to help communicate to MDH nurses during an on-site regulatory visit.

During an on-site visit, MDH nurses will interview staff, talk with clients and/or their representatives, make observations and review documentation. The survey is an opportunity for the licensee to explain to the MDH nurse what systems are in place to provide Assisted Living Home Care services. Completing this Licensing Survey Form in advance may facilitate the survey process.

Licensing requirements listed below are reviewed during a survey. A determination is made whether the requirements are met or not met for each Indicator of Compliance box. This form must be used in conjunction with a copy of the ALHCP home care regulations. Any violations of ALHCP licensing requirements are noted at the end of the survey form.

For Indicators of Compliance not met, the rule or statute numbers and the findings of deficient practice are noted below.

#### 1. MN Rule 4668.0065 Subp. 2

## AREA OF COMPLIANCE: # 5

Based on record review and interview, the licensee failed to ensure that tuberculosis screening was completed for one of two unlicensed employees at site A (AB) records reviewed. The findings include:

Employee AB began working February of 2006 as a direct care staff. Employee AB's record lacked evidence that a tuberculosis screening had been done. When interviewed, October 17, and 18, 2006 the registered nurse indicated they were unable to find documentation of employee AB having received a tuberculosis screening.

#### 2. MN Rule 4668.0855 Subp. 9

### AREA OF COMPLIANCE: #6

Based on record review and interview, the licensee failed to have complete medication records for four of four current clients' (A1, A2, B4, and B5) records reviewed. The findings include; Client A1 had a prescriber order dated June of 2006 for Levaquin 750mg one table daily for 14 days and Prednisone tab 50 mg one tablet daily for 5 days. The above medications were not included on client A1's medication administration record (MAR) for June 2006. When interviewed on October 16, 2006 registered nurses at site A confirmed the medications had not been documented as being given.

Client A1, A2, B4, and B5's September 2006 medication administration records (MAR) only indicated the name of the medication given and not the dosage of the medication to be given. When interviewed on October 16, and 17, 2006 the registered nurses at site A and site B confirmed the dose of the medication was not on the MAR.

#### 3. MN Rule 4668.0865 Subp. 2

#### AREA OF COMPLIANCE: #6

Based on observation, record review and interview, the licensee failed to ensure complete service plans for four of four current clients' (A1, A2, B4, and B5) records reviewed. The findings include:

When observed October 17 and 18, 2006 the medication storage cupboard contained medications that were centrally stored for clients A1, A2, B4, and B5. The service plans for clients A1, A2, B4, and B5 did not include central storage of medications. When interviewed on October 16, and 17, 2006 registered nurses at site A and site B confirmed the service plans did not include central storage of medications.

A draft copy of this completed form was left with <u>Libby Welsh</u> at an exit conference on <u>October 18</u>, <u>2006</u>. Any correction orders issued as a result of the on-site visit and the final Licensing Survey Form will arrive by certified mail to the licensee.
