#### LICENSING SURVEY FORM

## 1. MN Rule 4668.0815 Subp. 1

#### **INDICATOR OF COMPLIANCE: #6**

Based on record review and interview, the licensee failed to establish a client's service plan for one of one client (1) record reviewed. The findings include:

Client 1's "Review of Systems/Physical Assessment" was dated January 2008. There was no service plan established by the facility for the client. There was a care plan and a contract in the record between the facility and the Department of Human Services for payment of services. Neither document met the criteria for a service plan.

When interviewed April 14, 2009, the RN stated that she was not aware of the requirement to establish a service plan based on her assessment/evaluation of the client needs.

### 2. MN Rule 4668.0840 Subp. 5

#### **INDICATOR OF COMPLIANCE: #5**

Based on record review and interview, the licensee failed to ensure that competency evaluations were documented for one unlicensed employee (B) record reviewed. The findings include:

Employee B was hired February 2008, as an unlicensed direct care staff. He performed range of motion, condom catheter care and medication administration from March 1, 2009, through April 13, 2009, for client #1. Employee B's personnel records lacked evidence of competency for range of motion, condom catheter care and medication administration

When interviewed, April 13, 2009, employee B stated that he had done book and video training at the licensee's headquarters and then unlicensed staff had showed him how to perform range of motion, catheter care and give medications when he began working at the client's house. Then the nurse had watched him.

When interviewed, April 13, 2009, the licensed practical nurse stated the home care aide competencies should be at the personnel office. When interviewed April 14, 2009, the registered nurse stated the staff had received the training but the competency was not documented.

#### 3. MN Rule 4668.0855 Subp. 9

#### **INDICATOR OF COMPLIANCE:** #6

Based on record review and interview, the licensee failed to have complete medication records for one of one client (1) record reviewed.

Client #1 had weekly medication set-up by the licensed personnel and daily medication administration by unlicensed staff. The licensed personnel that performed the weekly set-up of medication had not documented each medication that was set-up and the unlicensed staff administering the medication daily had not documented each medication that was administered to the client. Documentation on the January, February, March and April 2009, medication administration records stated "medication box" and noted a designated time the medications were to be given. The unlicensed staff administering the medications documented their initials at the designated time the medications were to be administered. There was no documentation of which individual medications were set up or administered.

When interviewed, April 10, 2009, the registered nurse stated that the agency's Class A medicare license was used for the nurse to set up medications in order to bill the health insurance companies. When interviewed, April 13, 2009, the licensed practical nurse verified that each medication set up was not documented and she was not aware of this state licensing requirement.
