For Indicators of Compliance not met, the rule or statute numbers and the findings of deficient practice are noted below.

### **1. MN Rule 4668.0030 Subp. 4**

#### **INDICATOR OF COMPLIANCE: # 2**

Based on record review and interview, the licensee failed to ensure clients received a copy of the Minnesota Home Care Bill of Rights that contained up to date information for three of three clients' (#1, #2 and #3) records reviewed. The findings include:

Clients #1, #2 and #3 began receiving services from the licensee March of 2007, April of 2007 and September of 2006, respectively. When interviewed October 10, 2007, the owner provided the reviewer with a copy of the Minnesota Home Care Bill of Rights that he had provided to all of the clients. The Bill of Rights did not include the current telephone number of the Office of Health Facility Complaints, nor did it include the current address and telephone number of the Office of the Ombudsman for Older Minnesotans.

### **2. MN Rule 4668.0065 Subp. 1**

#### **INDICATOR OF COMPLIANCE: # 5**

Based on record review and interview, the licensee failed to ensure tuberculosis screening was completed for one of four employees' (A) records reviewed. The findings include:

Employee A, was hired by the licensee September of 2007 as a direct care staff. A tuberculosis screening document indicated employee A had a positive reaction to a Mantoux test April of 2002. He received a chest x-ray April of 2002, and the results were negative with no evidence of tuberculosis. There was no other evidence of tuberculosis screening in employee A's record. When interviewed on October 10, 2007, the owner stated he thought the chest x-ray dated April 12, 2002 was current enough for the employee A's employment at his agency.

### **3. MN Rule 4668.0100 Subp. 5**

#### **INDICATOR OF COMPLIANCE: # 5**

Based on record review and interview, the licensee failed to ensure complete training for two of two unlicensed employees' (C and D) records reviewed. The findings include:

Employees C and D both functioned as unlicensed direct care staff and provided personal cares to clients #1 and #2 respectively. The personal cares included bathing, feeding, and oral hygiene. There was no evidence of training on these topics in employee C or D's records. When interviewed October 11, 2007, the owner confirmed the lack of training and competency for these employees and all employees of the agency.

**4. MN Rule 4668.0100 Subp. 9****INDICATOR OF COMPLIANCE: # 5**

Based on record review and interview, the licensee failed to ensure that a registered nurse (RN) supervised unlicensed personnel who performed services that required supervision for two of three client (#1 and #2) records reviewed. The findings include:

Client #1 began receiving services March of 2007, which included bathing and oral hygiene. The last documented supervisory visit was dated July of 2007. Client #2 began receiving services April of 2007, which included bathing, oral hygiene and feeding. The last documented supervisory visit was July of 2007. When interviewed October 10, 2007 the owner stated the agency's registered nurse quit her employment at the end of July, 2007, and he just hired two registered nurses, but neither had started to do supervisory visits.
