Dear Senator Sheran, Senator Lourey, Representative Mack, and Representative Dean:

The 2007 Legislature required the Minnesota Department of Health (MDH) to annually report on the hospital-based cost of community benefit, community care amounts, and state public health insurance program underfunding (Minnesota Statutes, Section 144.699 subd. 5).

The enclosed report provides analysis of the community benefit spending for Minnesota's hospitals between 2008 and 2013; a report with 2014 data is under preparation by my agency. Findings from 2013 suggest that the state's community hospitals expended about \$1.1 billion in community benefit, up 2.1 percent from 2012 and 51.5 percent from 2008.

Direct patient care community benefit, remained the primary form of community benefit, accounting for just over three-quarters of the total in 2013. Spending on research and education was the other major category of community benefit spending in 2013(20 percent); hospital-provided community-centered activities and financial and in-kind expenses amounted to approximately two and one percent of community expenses, respectively.

Introduction

Community hospitals in Minnesota are an important part of the health care delivery system, accounting for 34.8 percent of the state's health care spending in 2013.¹ The vast majority of community hospitals are nonprofit or government institutions (78.1 percent and 21.2 percent, respectively). These institutions provide community benefit, many in part to satisfy obligations stemming from their status as tax-exempt entities.²

In 2007, the Minnesota Legislature passed legislation requiring the state's community hospitals – non-federal institutions that largely offer non-specialty services – to report to the Minnesota Department of Health (MDH) the amounts spent on community benefit.³ This report provides an analysis of historical trends of hospital community benefit, covering the period of 2008 through 2013.

It also briefly addresses community benefit requirements for hospitals derived from the Patient Protection and Affordable Care Act⁴ (ACA).

This report focuses on the nine categories of community benefit for which Minnesota law requires reporting (Table 1). These categories follow the guidelines and methodology developed by a partnership of not-for-profit and Catholic health organizations on hospital community benefit.⁵ As such, they explicitly do not include the costs of bad debt (care that was provided but for which the hospital is unable to obtain reimbursement from the patient), potential underpayment associated with Medicare services, or taxes paid, such as the MinnesotaCare tax. Also excluded from the definition of hospital community benefit in Minnesota law are any revenues hospitals received to offset these activities.

TABLE 1: HOSPITAL COMMUNITY BENEFIT CATEGORIES

Category	Definition or Examples
Direct Patient Care	
Community Care	Also called Cost of Charity Care. Care provided at a free or reduced amount. Charity care is care provided with no expectation of payment and is separate from bad debt.
State Health Programs Underpayments	The difference between payments for services provided to public program clients and the cost of providing these services. Also called underpayment for services provided under state health care programs.
Costs of operating subsidized services	Services that are operated at a financial loss, such as trauma services, burn units, and neonatal intensive care units.
Community health services cost	Examples include community health education, community based clinical services such as free clinics and screenings, health support services, and self-help programs.
Research and Education	
Education	Cost of providing medical education. Examples include student internship in clinical settings and scholarship for professional education.
Research	Cost of conducting research. This includes clinical research and community health research.
Financial and in-kind contributions	
Financial and in-kind contributions	Examples include hours donated by staff and overhead expenses of space donated to not-for-profit community groups.

Community Benefit: 2008 Through 2013

Data from Minnesota hospitals reported to the Minnesota Department of Health shows that 2013 hospital-based community benefit costs amounted to \$1.065 billion, a 2.1 percent increase over 2012 and up 51.5 percent from 2008 (Table 2).

While the increase in the volume of community benefit provided by Minnesota hospitals slowed in 2013 (from an average increase of \$85.1 million per year between 2008 and 2012, to \$21.4 million between 2012 and 2013), community benefit as a percent of total operating expenses stayed unchanged relative to 2012 (about 7.1 percent). This means, in aggregate, the provision of community benefit by Minnesota hospitals rose in concert with the overall hospital business.⁶

While community benefit that went to direct patient care accounted for just over three-fourths of community benefit spending, its share of total community benefit has decreased since 2008 (from 82.1 percent in 2008 to 76.1 percent in 2013). Meanwhile, community benefit devoted to research and education has nearly doubled since 2008, accounting for about 20 percent in 2013. Activities more directly related to supporting the community, for example through

economic development, environmental improvements, leadership training of community members, or the donation of staff time and overhead expenses for community groups, accounted for a small share of total community benefit (3.6 percent in 2013, down from 5.4 percent in 2008).

The single biggest category of hospital-based community benefit in 2013 and in every year since MDH has been monitoring community benefit, was unrealized revenue associated with delivering services to Medicaid and MinnesotaCare beneficiaries, or State Health Care Programs Underpayments. This community benefit category, which measures the difference between payments for services and the estimated costs of producing these services, accounts for almost half of the community benefit costs in 2013 and half of the \$362.2 million increase between 2008 and 2013.

Other takeaways across the study period are as follows:

- Community benefit spending for research, education and community benefit operation more than doubled between 2008 and 2013, but these categories accounted for less than one fourth of total community benefit in 2013 (up from almost 15 percent in 2008).
- Financial and in-kind contributions decreased nearly 45 percent between 2008 and 2013, with wide year-to-year swings.
- Community care, also called charity care, showed a large increase between 2008 and 2013, with most of the increase occurring between 2008 and 2010, when the economic recession was at its peak.

Community Benefit: 2012 to 2013

After growing at an average annual rate of 10.4 percent between 2008 and 2012, community benefit growth slowed considerably between 2012 and 2013, increasing only 2.1 percent, or \$21.4 million. Growth by category was highly variable, as shown in Figure 1.

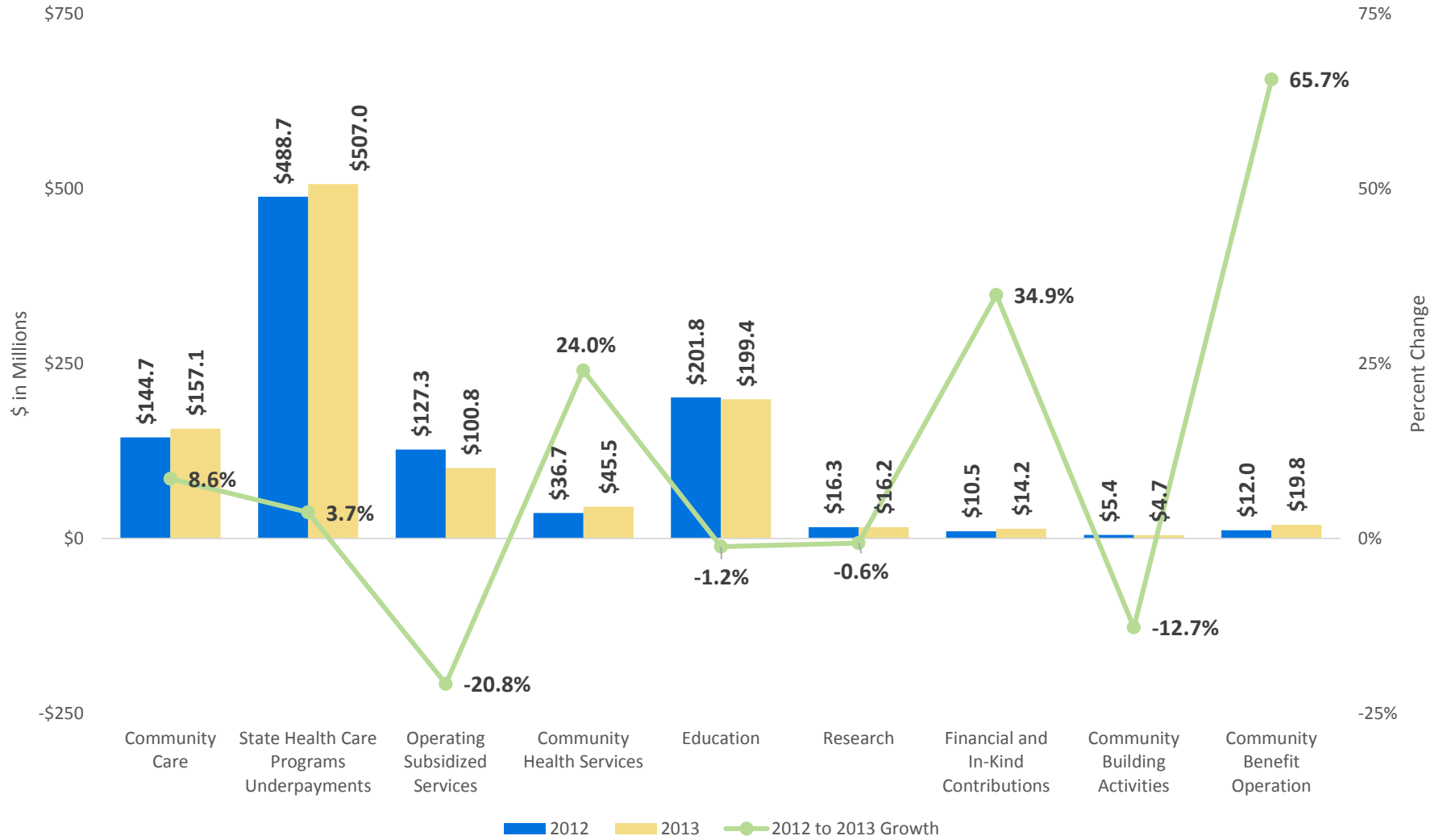
- Community benefit operations saw the largest increase between 2012 and 2013 with a 65.7 percent growth;
- Financial and in-kind contributions rose 34.9 percent, and
- Community health services increased 24.0 percent.

Together, these categories accounted for less than 10 percent of community benefit spending and the increases were partially offset by declines in operating subsidized services (-20.8 percent) and community building activities (-12.7 percent).

The modest increase in overall community benefit between 2012 and 2013 was driven largely by trends in the two largest community benefit categories, a modest increase in state health care program underpayments (3.7 percent compared to a 10.7 percent average annual growth since 2008) and a minimal decline in levels of education spending (a 1.2 percent decline).

Community Benefit by Hospital Characteristics

The amount of community benefit provided by hospitals in Minnesota varied by the location, size and type of facilities, as demonstrated in Table 3. Hospitals located in the Twin Cities Metropolitan area, home to 53.4 percent of the state's population, provided 64.0 percent of the total community benefit for the state. This region is home to the five largest providers of hospital services in the state, many of which are teaching facilities and are actively involved in clinical research, which is a major reason why this area provides such a high percentage of community benefit. These hospitals also devoted a larger percentage of operating expenses (8.3 percent) to community benefit than the state average (7.1 percent). Hospitals in Northwest and Southwest Minnesota also provided a higher percent of operating expenses in community benefit than the state average. While the change between 2012 and 2013 was variable across regions, only Northeast Minnesota saw a large decline in community benefit, which was driven largely by a decrease in community benefit spending by urban hospitals in the region.

Hospitals located in urban areas account for only two fifths of hospitals, but provide nearly four-fifths of the community benefit in the state in both 2012 and 2013. While primarily driven by Twin Cities hospitals, urban hospitals outside of the Twin Cities Metropolitan area also tend to be larger teaching hospitals. Nonetheless, rural hospitals exhibited a larger increase in community benefit between 2012 and 2013 than their urban counterparts (4.9 percent and 1.3 percent, respectively).

Large hospitals (200 or more beds) exhibited slower growth (1.6 percent) between 2012 and 2013 than smaller hospitals with fewer than 100 beds (5.3 percent, data not shown). These smaller hospitals devoted more resources in 2013 to operating subsidized services, research, and community building activities than in 2012, while the large hospitals actually saw declines in these areas.

New Federal Reporting Requirements

Until 2008, hospitals that were organized as charitable institutions under Section 501(c)(3) of the Internal Revenue Code were granted broad latitude in defining activities and services they considered community benefit. While some states took a more active role in assessing how effectively non-profit institutions met their obligation under state laws and required certain volumes of community benefit or charity care, in most jurisdictions hospitals and their boards

independently determined how much resources to invest in community benefit. This resulted in substantial variation of practices and volume of community benefit delivered across the country.⁷ With the passage of the ACA, non-profit hospitals face new requirements related to their tax exempt status, including to report annually on a series of standard, clearly defined community benefit activities.^{8,9}

In important ways, the IRS reporting categories and definitions align well with those in Minnesota. Consistent with Minnesota, the following expenditure categories are specifically excluded from the calculation of community benefit:

- Estimates of hospital bad debt;
- The differences between payment and the cost of care for Medicare beneficiaries, also termed “Medicare underpayments;” and
- Taxes paid, such as the MinnesotaCare (provider) tax.

In addition, institutions are required to report community benefit spending (or foregone revenue) net of payments received in support of them, for instance through grants or donations.

Federal reporting requirements differ from the state’s requirements in two ways: (1) the requirements only extend to private, non-profit facilities. Government-owned hospitals are not subject to the federal requirements, while they are required to report in Minnesota. (2) IRS reporting is permitted at the institution-level, meaning the accounting of community benefit activities derives from efforts that may include outpatient clinics, nursing homes, wellness centers and other affiliated business entities, depending on how ownership of services within institutions is structured. This makes comparisons between data collected by Minnesota and that collected at the federal level complex.

At this point, no analysis of the federal data is available, so MDH cannot compare Minnesota patterns to those observed in other states using consistent categories. MDH will continue to monitor the availability of these data, with a goal of assessing the quality of the data and its potential utility for policy-making in Minnesota.

Summary

Although Minnesota hospital community benefit has increased by more than 50 percent since 2008, totaling over \$1 billion in 2013, growth has slowed. Similarly, while the share of operating expenses devoted to community benefit gradually increased from 5.9 percent in 2008 to 7.1 percent in 2012, it remained stable in 2013. As in the past, community benefit devoted to direct patient care accounted for most of 2013 community benefit, with much of this related to the difference between costs and payments for public program beneficiaries' care and charity care expenditures. Education expenditures account for nearly two out of every 10 community benefit dollars.

On average, both rural and urban hospitals contribute just over seven percent of their operating expenses to community benefit; however, there is significant variation across individual facilities by region and size of facility.

While Minnesota has required community benefit reporting for nearly a decade, new federal requirements under the ACA for nonprofit hospitals may allow for future comparisons of the state to national data. This is particularly important, as the distribution of hospital community benefit may change or the volume may decline if insurance coverage in Minnesota continues to rise and with it, the need for charity care continues to decline.^{10,11} Future reports from MDH will monitor trends and include reporting on changes over time.

Data Sources and Limitations

The Minnesota data contained in this report comes from the Hospital Annual Report submitted by the Minnesota Hospital Association, MDH's vendor to collect hospital data on finances, utilization and available services.

Detailed data on community benefit provided by each hospital are reported in Table 4 and Table 5 at the end of this report. However, when comparing across hospitals, caution is recommended as individual hospitals' ability to track these costs continues to vary. Also, not all hospitals were able to fully report offsetting revenues for community benefit or systematically track expenses for research and education. Some hospital systems continue to have difficulty with accurately distributing the aggregate community benefit across individual facilities.
