

Body Art Announcements

The 2017 Minnesota Legislative session approved changes to the Body Art Program Chapter 146B. These statute changes will be effective July 1, 2017.

The Department will provide updated information including application forms on Minnesota Department of Health, Body Art Program website before July 1, 2017. The Department will process the applications postmarked before July 1, 2017 according to the statutes of 2016.

Changes include: increases to existing application fees, new fees, and changes to application requirements.
