It's time to order MnVFC influenza vaccine for the 2011-12 influenza season. As in years past, the MnVFC program only provides influenza vaccine for eligible children age 18 years of age and younger. Adults age 19 and older on a Minnesota Healthcare Program (MHCP) are not eligible for MnVFC vaccine. If you see MHCP adults you can use private stock and submit a claim to the patient's insurer.

### How to Order Influenza Vaccine

- To order via paper, use the attached *MnVFC Pediatric Influenza Vaccine Order Form*.
- Do not do both or you may receive double the amount of vaccine you really need!
- Not ordering influenza vaccine? **Please submit an order form even if you are not ordering influenza vaccine.** You can do this by:
  - Selecting the "No, I do not wish to prebook influenza vaccine from the Minnesota Department of Health" option online.
  - Placing an X in the box next to "Please check here if you will NOT be ordering influenza vaccine" on the paper form.
- We will compare your request for doses with your *Annual Report of the Number of MnVFC Patients Immunized* to validate your order.

Influenza vaccine orders are **due by March 16, 2011**. We will let you know as soon as possible when you will receive you influenza vaccine.

### Vaccine Product Information

- The trivalent vaccine for the 2011-2012 influenza season will likely contain the strains found in the 2010-2011 influenza vaccine:
  - Influenza A (H1N1) strain A/California/7/2009 (H1N1)-like virus,
  - Influenza A (H3N2) strain A/Perth/16/2009 (H3N2)-like virus, and
  - Influenza B/Brisbane 60/2008-like virus.
- Both inactivated (TIV) and live attenuated (LAIV) flu vaccine products are available (i.e., Fluzone and FluMist).
- Be sure to order enough thimerosal-free influenza vaccine (i.e., Fluzone pre-filled syringes and FluMist) for children whose parents may request it.
- The MnVFC program will make every effort to fill your request, but we may need to adjust your request based on product availability.
- As you prepare your order, keep in mind that LAIV is growing in popularity among children and adolescents (parents too!).

**Still Have Influenza Vaccine from this Year (2010-11)?**

- Keep vaccinating – flu season isn't over yet!
- Try to finish the second dose in infants and children who need it. You can continue to do so until the vaccine expires.
- Check influenza vaccine expiration dates. The expiration date for inactivated flu vaccine is June 30 of each year. Expiration dates for LAIV vary as it usually expires much sooner than TIV.
- If you have expired and unused MnVFC influenza vaccine, please contact the MnVFC program before returning it to the distributor, McKesson.

 All nonviable MnVFC vaccine (expired or spoiled) must be returned to McKesson. Contact MDH for approval before you send the vaccine. Use the **Returning Nonviable MnVFC Vaccine** form and mail the vaccine to McKesson at the address listed on the form.

This order form must be signed by a licensed practitioner who is authorized to procure vaccine/biologicals according to Minnesota Statutes, Section 151.37 (e.g., M.D., D.O., nurse practitioner, physician's assistant, or pharmacist). Please include the individual's title.

**\*Preservative-free vs. thimerosal-free**

Vaccines with trace amounts of thimerosal are labeled as preservative-free. Vaccines that do not contain any thimerosal are labeled as thimerosal-free.

Thimerosal is still used in the early stages of manufacture of a few vaccines to ensure the production line is sterile. It is removed through a purification process, with only trace remaining (about 1/100th of the amount found in older vaccines).
