## Fasiraadda iyo Dhaqan-gelinta Xuquuqda

Bixiyaha adeegyada hospice-ka looma oggola inuu qof ku qasbo inuu ka tanaasulo xuquuqahan si uu u helo daryeelka hospice-ka. Masuul sharciyeed ama ilaaliye hantiyeed ama, haddii uusan jirin masuul sharciyeed ama ilaaliye hantiyeed, qof loo magacaabay, ayaa raadin kara in la dhaqan geliyo xuquuqahan. ## Shaacinta

Nuqul ka mid ah xuquuqdan waa in la siiyaa qofka marka la bilaabay daryeelka hospice-ka. Nuqulka waa inuu ku jiraa cinwaanka iyo lambarka taleefanka ee Xafiiska Cabashooyinka Xarumaha Caafimaadka (Office of Health Facility Complaints) iyo Xafiiska Difaaca Xuquuqda Daryeelka Mudada Dheer (Office of Ombudsman for Long-Term Care), iyo bayaan kooban oo sharxaya sida cabasho looga gudbiyo xafiisyadan. Macluumaadka ku saabsan sida loola xiriiro Xafiiska Difaaca Xuquuqda Daryeelka Mudada Dheer waa in sidoo kale lagu daraa ogeysiisyada isbeddelka khidmadaha bixiyaha iyo ogeysiisyada ay bixiyeyaasha hospice-ku ku bilaabayaan wareejinta ama joojinta adeegyada.

## Bayaanka Xuquuqda

Qofka hela daryeelka hospice-ka waxa uu xaq u leeyahay inuu:

1. helo macluumaad qoraal ah oo ku saabsan xuquuqdiisa ka hor inta uusan helin daryeelka hospice-ka ama inta lagu jiro booqashada qiimaynta hore inta aan la bilaabin daryeelka hospice-ka, oo ay ku jirto waxa la samaynayo haddii xuquuqdu la jabiyay;
2. helo daryeel iyo adeegyo la waafajiyay qorshe daryeel hospice oo ku habboon, isla markaana waafaqsan heerarka la aqbalay ee daryeelka hospice-ka, iyo inuu ka qaybqaato si firfircoon samaynta, beddelidda, iyo qiimaynta qorshaha iyo adeegyada;
3. in loo sheego ka hor inta aanu helin daryeelka adeegyada la siin doono, qaybaha kala duwan ee howl-wadeenada bixiya daryeelka, inta jeer ee booqashooyinka la qorsheeyay, doorashooyinka kale ee jira, iyo cawaaqibka doorashooyinkaas, oo ay ku jiraan cawaaqibka ka iman kara diidmada adeegyadaas;
4. in loo sheego horay, markasta oo ay suurto gal tahay, wixii isbeddel ah ee ku yimaadda qorshaha daryeelka hospice-ka, isla markaana uu si firfircoon uga qayb qaato isbeddel kasta;
5. inuu diidi karo adeeg ama daawayn;
6. inuu horay u ogaado xaddidaadaha adeegyada uu bixiyo bixiyaha, iyo sababaha bixiyaha ugu joojin karo adeegyada;

7. inuu horay u ogaado ka hor inta aanu helin daryeelka haddii adeegyada hospice-ka dabooli karaan caymis caafimaad, gargaar caafimaad, Medicare, ama barnaamijyo kale oo caafimaad oo uu ku jiro.
8. inuu helo, marka uu codsado, qiyaas daacad ah oo ku saabsan lacagta magdhawga ah ee bixiyaha ka filayo inuu ka helo shirkadda caymiska caafimaadka ee uu ku jiro. Qiyaas daacad ah waa in sidoo kale la siiyaa qof aan ku jirin shirkad caymis caafimaad haddii uu codsado. Macluumaadkan lacag-bixinta ma aha qiyaas sharci ahaan ku waajibaysa oo ku saabsan kharashka adeegyada;
9. inuu ogaado in laga yaabo inay jiraan adeegyo kale oo bulshada dhexdeeda laga heli karo, oo ay ku jiraan adeegyada kale ee daryeelka dhamaadka nolosha iyo bixiyeyaasha kale ee hospice-ka, isla markaana uu ogaado meesha uu ka heli karo macluumaad ku saabsan adeegyadaas;
10. inuu si xor ah u doorto bixiyeyaasha jira, isla markaana uu beddeli karo bixiyaha ka dib marka adeegyada la bilaabo, iyadoo ay xaddidan tahay waxa ay oggol yihiin caymiska caafimaad, gargaar caafimaad, Medicare, ama barnaamijyada kale ee caafimaad;
11. in macluumaadkiisa shakhsiga ah, maaliyadeed, iyo caafimaad la ilaaliyo oo loo daayo qarsoodi, iyo in lala wargeliyo siyaasadaha iyo habraacyada bixiyaha ee la xiriira shaacinta xogta noocaas ah;
12. inuu helo marin uu ku heli karo diiwaannada iyo macluumaadka qoraalka ah ee ku jira diiwaannada, sida ku cad qaybaha 144.291 ilaa 144.298;
13. inuu helo adeeg ay bixiyaan shaqaale si habboon loo tababaray oo karti u leh gudashada waajibaadkooda;
14. in loola dhaqmo si edeb leh oo ixtiraam leh, isla markaana hantida bukaanka loola dhaqmo si ixtiraam leh;
15. inuu cabasho ka dhiiban karo daryeelka ama daawaynta la bixiyay ama aan la bixin, ama ku saabsan ixtiraam darro ama edebdarro loo muujiyay bukaanka ama hantida bukaanka;
16. inuu ka xoroobo jirdil jireed iyo aflagaaddo afka ah.
17. inuu helo ogeysiis macquul ah oo hore oo ku saabsan isbeddelada adeegyada ama khidmadaha, oo ay ku jiraan ugu yaraan toban maalmood oo ogeysiis hore ah marka bixiyuhu joojinayo adeeg, marka laga reebo xaaladaha halkaas oo:
  - a. qaataha adeegga uu ku dhaqmo si beddela xaaladaha shaqo ee u dhexeeya bixiyaha hospice-ka iyo shaqsiga bixiya adeegyada hospice-ka, ama abuura jawi shaqo oo aflagaaddo ah ama aan ammaan ahayn shaqsiga bixiya adeegyada hospice-ka;
  - b. degdeg ku yimid daryeel-bixiyaha aan rasmiga ahayn ama isbeddel weyn oo ku dhacay xaaladda qaataha adeegga ay keeneen baahiyo adeeg oo ka badan heshiiska adeeg-bixiyaha ee hadda jira, oo aan si ammaan ah loogu dabooli karin bixiyaha hospice-ka; ama
  - c. qaataha adeegga aanu sii ahaan shahaado ahaan u cuslayn oo cudurkiisa uusan mar dambe loo tixgelin inay tahay xaalad dhimasho dhow;
18. inuu helo wareejin isku-duuban marka uu dhici doono isbeddel ku yimaadda bixiyaha adeegyada;
19. inuu ogaado sida loola xiriiro shaqsi ka tirsan bixiyaha oo mas'uul ka ah xallinta dhibaatooyinka, iyo in bixiyaha baaro oo isku dayo inuu xalliyo cabashada ama dacwadda;
20. inuu ogaado magaca iyo cinwaanka hay'adda gobolka ama degmada ee lala xiriiro si loo helo macluumaad ama gargaar dheeraad ah;

21. inuu xuquuqdan ku dhaqmo naftiisa, ama qoyska bukaanka hospice-ku ay ku dhaqmaan haddii bukaanka lagu go'aamiyo inuusan awood u lahayn, iyada oo aan lagu ciqaabin;
22. in lagu maareeyo xanuunka iyo astaamaha heerka uu bukaanku doorbido ee raaxada, oo ay ku jiraan hubinta in daawooyinka ku habboon si fudud loogu heli karo bukaanka;
23. inuu joojin karo doorashada hospice-ka wakhti kasta; iyo
24. inuu helo daawayn bogsii ah oo ku saabsan xaalad kasta oo aan la xiriirin cudurka u qalmeeyay daryeelka hospice-ka, isaga oo weli ku jira doorashada hospice-ka, isla markaana lala kaashanayo bixiyaha hospice-ka haddii ay suurto gal tahay.

## Ilooyin
