On January 25, 2021 a survey was completed at your facility by the Minnesota Department of Health to investigate complaint(s) to determine if your facility was in compliance with Federal participation requirements for skilled nursing facilities and/or nursing facilities participating in the Medicare and/or Medicaid programs. At the time of survey, the complaint(s) were substantiated but no deficiencies were issued, because corrective action was taken prior to the survey. A plan of correction is not required.
