This MN Requirement is not met as evidenced by: Based on interview and record review, the licensee failed to ensure employment of a licensed assisted living director (LALD), licensed by the Board of Executives for Long Term Services and Supports (BELTSS). This had the potential to affect all residents and staff. This practice resulted in a level two violation (a violation that did not harm a resident's health or safety but had the potential to have harmed a resident's health or safety) and was issued at a widespread scope (when problems are pervasive or represent a systemic failure that has affected or has the potential to affect a large portion or all of the residents). The findings include: The licensee held an assisted living facility (ALF) license with a capacity of eight residents issued on March 1, 2025, through February 28, 2026. On April 30, 2025, at 12:30 p.m., the investigator observed the facility did not have an assisted living director (ALD) or LALD license displayed in the facility. On April 28, 2025, at 1:00 p.m., LALD-D stated she was the LALD for five of the licensee's facilities but had not been the director since April 14, 2025. On April 29, 2025, at 12:35 p.m., registered nurse (RN)-B stated the licensee did not have a current LALD. On April 30, 2025, at 1:45 p.m., administrative assistant (ADM)-C (former vice president) confirmed the facility did not have a current LALD or an assisted living director-in residence (ALD-IR). The previous LALD left the position on April 14, 2025. ADM-C stated the company had tried to fill the position but that had been difficult. ADM-C had not checked with a consulting company to fill the positions and was hoping to fill the positions internally. On May 9, 2025, at 3:39 p.m., the BELTSS website indicated there was no current director of record listed and the last director of record ended on April 14, 2025. The licensee's Assisted Living Director policy dated June 7, 2023, indicated the licensee was required to have an assisted living director licensed or permitted by the board of directors. The licensed or permitted assisted living director will maintain a current and active license or permit with BELTSS.
