**Nature of Investigation:**

The Minnesota Department of Health investigated an allegation of maltreatment, in accordance with the Minnesota Reporting of Maltreatment of Vulnerable Adults Act, Minn. Stat. 626.557, and to evaluate compliance with applicable licensing standards for the provider type.

**Initial Investigation Allegation(s):**

The alleged perpetrator (AP) neglected a resident when she failed to provide toileting assistance which resulted in the resident sustaining skin excoriation. The resident required hospitalization.

**Investigative Findings and Conclusion:**

The Minnesota Department of Health determined neglect was not substantiated. Although the resident was not toileted during the night, she had an acute (sudden) change in her condition caused by illness. The skin rash was chronic (long-term), and she was receiving treatment for it prior to the AP's shift. Hospital records indicated the resident was ill from sepsis (a life-threatening infection) caused by an infection of her toe.

The investigator conducted interviews with facility staff members, including administrative staff, nursing staff, and unlicensed staff. The investigator contacted former employees. The

investigation included review of medical records, hospital records, and employee files. Also, the investigator toured the facility and observed interactions between the staff and residents.

The resident resided in an assisted living facility. The resident's diagnoses included multiple sclerosis, high blood pressure, peripheral vascular disease (circulation disorder), and osteoporosis. The resident's service plan included assistance with dressing, bathing, and toileting. The resident's nursing assessment indicated she has short term memory impairment, but was alert and orientated. She was able to communicate and make her needs known. The resident used a wheelchair and a walker for mobility.

The resident's records indicated the resident was at a long-term care center and returned to the facility three days prior to the incident.

Service delivery records indicated the AP documented she provided toileting assistance once during the night at 12:25 a.m. The resident was next toileted by day shift staff at 6:05 a.m.

The resident's progress notes indicated nursing staff sent the resident to the hospital because she had increased weakness and required more assistance than the facility could provide. The resident required two staff to assist her in transfers and toileting when she generally only required minimal assistance. She also had an inflamed skin rash on her buttocks.

Hospital records indicated the resident was ill from sepsis and required an amputation of her toe. The records indicated she had other chronic health problems which contributed to her decline in health. The records indicated the hospital prescribed ointment for the treatment to the resident's skin rash from incontinence. The resident's health condition improved, and the hospital discharged her to the transitional care unit.

Facility investigation documents indicated the AP charted she provided toileting assistance to the resident twice during the night, but video footage showed no staff members entered the resident's apartment.

Review of service delivery records and complaint history indicated the facility failed to have an accurate service delivery record system for unlicensed personnel (ULP) that included the scheduled time a service was due, to ensure ULP were documenting provided services accurately and ensure ULP were indeed providing the services. The facility had other resident complaints of services not being provided and upon review of security video footage, found those complaints were valid.

During an interview, a manager said she sent the resident to the hospital because she had a drastic change in her condition. The manager said she observed the video footage to see if the resident was toileted during the night because the morning staff found the resident soiled with incontinence. The manager said video footage did not show any staff members enter the resident's room during the night. The manager said there were two staff in the building during

the night, but the AP was responsible to provide services to the resident. The manager said a former nurse instructed staff to document they provided services even if they had not provided them. The manager said she educated staff on proper documentation after this incident. The manager said the resident appeared at her normal health status the day prior.

The AP said there was confusion regarding the resident's return from the long-term care center, but historically the resident was independent and took herself to the bathroom. The AP said she was not fully aware of the circumstances of the investigation but she did provide care to the resident.

In conclusion, the Minnesota Department of Health determined neglect was not substantiated.

**"Not Substantiated" means:**

An investigatory conclusion indicating the preponderance of evidence shows that an act meeting the definition of maltreatment did not occur.

**Neglect: Minnesota Statutes, section 626.5572, subdivision 17**

"Neglect" means:

(a) The failure or omission by a caregiver to supply a vulnerable adult with care or services, including but not limited to, food, clothing, shelter, health care, or supervision which is:

(1) reasonable and necessary to obtain or maintain the vulnerable adult's physical or mental health or safety, considering the physical and mental capacity or dysfunction of the vulnerable adult; and

(2) which is not the result of an accident or therapeutic conduct.

**Action taken by facility:**

The facility provided education for staff on proper documentation and services.

**Action taken by the Minnesota Department of Health:**
