As a result of the investigation, the licensee was determined not to be in compliance with 144A.484 Integrated Licensure: Home and Community Based Service Designation. 08000	Continued From page 2 Based on interview and record review, the licensee did not provide at least one (1) home care service for all seven (7) clients identified as a client who received services under the home and community-based service (HCBS) integrated license designation, that would otherwise require (separate) licensure under chapter 245D. This practice resulted in a level two violation (a violation that did not harm a client's health or safety but had the potential to have harmed a client's health or safety, but was not likely to cause serious injury, impairment, or death), and was issued at a widespread scope (when problems are pervasive or represent a systemic failure that has affected or has potential to affect a large portion or all of the clients). The findings include: The licensee's (renewal) application for Integrated License: Home and Community-Based Services (HCBS) Designation was signed on August 15, 2025, by owner (O)-A. The application directed, "A licensed home care provider with an integrated license: HCBS designation (designation) must comply with the requirements for home care providers governed by Minnesota Statutes, sections 144A.43 - 144A.484. The licensee was also directed to indicate with a check mark any basic support services (as defined in 245D.03) that they will provide. The licensee indicated they were enrolled to provide seven (7) basic support services. On March 12, 2026, at 3:33 p.m., via email O-A indicated their clients were served under their basic 245D license, receiving services including night supervision, individualized home supports	08000

On March 12, 2026, at 3:34 p.m., a review of the licensee's current client roster dated March 12, 2026, listed seven (7) clients with a start of service date but the rest of the form was blank (no check marks indicating what services were provided). On March 13, 2026, at 11:08 a.m., O-A provided Department of Human Services (DHS) billing statements dated February 10, and 24, 2026, indicated the following billing codes were used for the licensee's 245D clients: -S5130- homemaking -S5135 UC- individualized home supports without training -S5150- respite care services During phone interview on March 13, 2026, at 12:17 p.m., O-A stated C7 (seventh client) was currently receiving services such as homemaking, individualized home supports without training, and night supervision, but had not received payment yet as they were waiting on C7's service agreement.
