Under the section 245D Basic Support Services Offered the application directed, "A licensed home care provider with an integrated license: HCBS designation (designation) must comply with the requirements for home care providers governed by Minnesota Statutes, sections 144A.43 - 144A.484."</p> <p>The licensee was also directed to indicate with a check mark any basic support services (as defined in 245D.03) that they will provide.
