## **8. New data and resources on intimate partner violence and sexual violence**

Intimate partner violence (IPV) is a significant public health problem in the United States. Data collected from over 70,000 respondents in 2005 found that approximately 1 in 4 women and 1 in 7 men reported some form of lifetime IPV victimization. New research from the Centers for Disease Control and Prevention (CDC) finds that men and women reporting IPV are significantly more likely to experience a number of chronic health conditions ([www.cdc.gov/mmwr/preview/mmwrhtml/mm5705a1.htm](http://www.cdc.gov/mmwr/preview/mmwrhtml/mm5705a1.htm)).

To help healthcare practitioners better identify and treat victims, CDC recently developed Intimate Partner Violence and Sexual Violence Victimization Assessment Instruments for Use in Healthcare Settings. This compilation provides practitioners and clinicians with an inventory of existing assessment tools for determining intimate partner violence and/or sexual violence victimization. It also helps inform decisions about which instruments are most appropriate for use with a given population. This document will aid in the selection of assessment instruments to identify victims requiring additional services. It can also help practitioners make appropriate referrals for both victims and perpetrators.

Troubled adolescents most at risk, researchers find, and few offenders pose as fellow teens

WASHINGTON - A lot of parental worries about Internet sex predators are unjustified, according to research by a leading center that studies crimes against children.

"There's been some overreaction to the new technology, especially when it comes to the danger that strangers represent," said Janis Wolak, a sociologist at the Crimes Against Children Research Center at the University of New Hampshire in Durham.

"Actually, Internet-related sex crimes are a pretty small proportion of sex crimes that adolescents suffer," Wolak added, based on three nationwide surveys the center conducted.
