6. New CDC publication: Child Maltreatment Surveillance: Uniform Definitions for Public Health and Recommended Data Elements

Child maltreatment is a significant social and public health problem in the United States (U.S.). In 2006, child protective services confirmed that approximately 905,000 children in the U.S. were victims of maltreatment and 1,530 died from abuse or neglect. Unfortunately, these numbers likely underestimate the magnitude of the problem in this country.

Calculation of victimization rates for child maltreatment depends on how the definition is operationalized. Currently, the multiple sectors (child protective services, legal and medical communities, public health officials, practitioners, and advocates) addressing this problem use their own definitions. This limits communication across sectors and hampers prevention efforts.

The Centers for Disease Control and Prevention (CDC) is pleased to announce the publication of Child Maltreatment Surveillance: Uniform Definitions for Public Health and Recommended Data Elements. This document provides conceptual definitions of child maltreatment, presents associated terms, and recommends data elements for voluntary use by the public health community in the development of surveillance systems.

Purpose: To raise the awareness of traditionally underserved populations on victims' rights as well as improve their knowledge on how to access local services available to crime victims. Funding will support the planning and development of victimization-focused public awareness campaigns targeted at underserved populations which may include, but are not limited to, victims who are immigrants with limited English proficiency, American Indian, have disabilities, or are deaf or hard-of-hearing.

Eligible Applicants: Private nonprofit organizations, including faith-based and community-based organizations, or public agencies that can demonstrate (1) knowledge and understanding of the victimization issue or issues to be highlighted in the public awareness campaign; (2) experience in the provision of victim services and advocacy; and (3) staff resources and capability to carry out all activities required by the funded project.

Estimated Available Funds: \$350,000.

Maximum Award Size: \$75,000.

Estimated Number of Awards: Up to 5.
