American Indian females are being disproportionately targeted by traffickers for the purposes of commercial sexual exploitation - they are victims of overall sexual violence 3 times as often as other women.

Environmental conditions leading to vulnerability to predators exist on most of America's Indian reservations, and jurisdictional complexities are barriers to reporting and prosecuting sexual assault against American Indian

women. This presentation will offer an overview of the issue of trafficking, what is happening in Minnesota, and a focus on how this issue is impacting American Indian communities.

## **2. Gerald D. Vick Human Trafficking Conference, St. Paul, MN, September 23-24, 2008**

The Saint Paul Police Department and the Gerald D. Vick Human Trafficking Task Force in conjunction with the United States Attorney's Office for the District of Minnesota will present a two day conference (September 23-24, 2008) addressing the problem of human trafficking. Domestic and international criminals have made trafficking, smuggling, and sex slavery booming businesses that can reach every community through out our country. Often a hidden crime, this conference will teach attendees how to look beneath the surface to uncover these crimes in hopes of rescuing victims and holding offenders accountable.

This conference will focus on how to recognize the crime of human trafficking in the community and work together to combat the problem. Topics to be covered include:

How to define the crime of human trafficking;

How to identify victims of human trafficking;

What tools and programs are available to help victims of human trafficking;

How to investigate crimes of human trafficking, including the essential use of task forces;  
What it takes to prosecute a human trafficking case;  
Why community collaboration is essential to address the problem.

The instructors will show why law enforcement and service providers must work together in a victim-centered approach when investigating and combating human trafficking. Attendees will learn how multi-agency, multi-jurisdictional task forces operate and learn from case studies of successful human trafficking investigations.

## **4. One of these things is not like the other; one of these things is not the same – Op Ed piece submitted to the Minneapolis Star Tribune**

Sex toys and smoke shops may be considered “naughty” by some, but buying people for sex must stop here. In the Variety section of Tuesday’s (July 8th) Star Tribune, Gail Rosenbaum kicked off a series of features dubbed “both quirky and practical” on “how the Republican National Convention will affect daily life in the Twin Cities”. However, the reality for victims of prostitution and sex trafficking is hardly quirky or practical.

Prostitution and sex trafficking is a significant problem in Minnesota. It has been estimated that 8,000 to 12,000 people are involved in prostitution in Minnesota every day. New research indicates that the average age of entry is getting younger with the current average age being 12.

Think about that for a moment—twelve years old – 6th grade.

Children coerced into prostitution and sex trafficking stay “in the life” well into adulthood, which exacts a heavy toll on victims and is far from a victim-less crime. Mortality rates for women who have been involved in prostitution are 200 times higher than women of similar age and race who have not been coerced into prostitution. Prostitution causes many health problems including higher rates than the general population of cancer (particularly cervical); chronic disease, pelvic inflammatory disease; traumatic brain injury and more. It

is clear that the cost of prostitution and sex trafficking is high for its victims.

In Minnesota and Colorado, where the Democratic Convention will be held, purchasing people for sex is a crime and therefore “john’s” (purchasers) must be held accountable. Much like former New York Governor Elliot Spitzer, men arrested for soliciting a prostituted person or child are often in marriages or steady relationships, and a smaller percentage of those show significant psychopathology when tested. “john’s” aren’t just being ‘naughty’ --they are committing a crime.

Ms. Rosenbaum is correct when she says, “bad behavior is bipartisan”, that is precisely why a grassroots collaboration of survivors, state government, non profit agencies, and community activists who are committed to ending sexual exploitation, have come together in Minnesota and Colorado to raise awareness about the realities of prostitution and sex trafficking. Our goal is to help ensure safety for victims while holding perpetrators accountable and to challenge national, state, and local policy leaders to join us in preventing prostitution and sex trafficking.
