## **13. New Publication: Sex Trafficking Needs Assessment for the State of Minnesota**

New Publication: Sex Trafficking Needs Assessment for the State of Minnesota

At the request of the State of Minnesota's Human Trafficking Task Force, The Advocates for Human Rights has prepared and published a needs assessment on sex trafficking in Minnesota. The report examines the government response to this issue at the local, state, tribal and federal levels; identifies facilities and services currently available to trafficking victims in Minnesota; assesses their effectiveness; and makes recommendations for coordinating services to better meet the needs of sex trafficking victims statewide.

Sex trafficking violates women and children's basic human rights, including the right to be free from slavery and slavery-like practices; the right to equal protection under the law; the right to be free from discrimination based on race, nationality, and gender; and the rights to life, security of person and freedom from torture. Governments also violate trafficked persons' rights when they fail to prevent sex trafficking, prosecute perpetrators or provide trafficked persons with effective remedies for these violations, such as access to courts and legal immigration status.

Speaking at the September 22nd press conference announcing the publication of the report, Cheryl Thomas, Director of the Women's Human Rights Program at The Advocates, said, "These findings [in the report] show that there is a significant group of people in Minnesota who profit from the sale of human beings for sex, and that there are those who fuel and encourage this sex trade through their own purchase of sex. Our findings show that these transactions in human beings cause devastating and long-lasting harm and suffering to those who are purchased in this way."

Robin Phillips, The Advocates' Executive Director, noted that "Minnesota has long been a leader in developing effective programs to address violence against women that are emulated around the world. Many individuals and agencies in Minnesota are deeply committed to protecting the human

rights of the victims of trafficking and holding perpetrators accountable for their crimes. We have included many of these best practices in the report, as well as some from other jurisdictions."

## **16. New research from Child Trends: Nearly One in Five Young Adult Women in US Report Having Experienced Forced Sex**

New research from Child Trends: Nearly One in Five Young Adult Women in US Report Having Experienced Forced Sex

New research from Child Trends finds that 18 percent of women age 18 to 24 report having experienced forced sexual intercourse at least once in their lives. The research, summarized in a fact sheet entitled Forced Sexual Intercourse Among Young Adult Women, also shows:

- \* The most common types of force are verbal or physical pressure, and being physically held down. More than half the women forced to have sexual intercourse report experiencing each of these types of force.
- \* Approximately a quarter of the women report being physically hurt.
- \* Among these young adult women, those who are white, black, Hispanic, or of another race are equally likely to report having ever experienced forced sexual intercourse.

Child Trends conducted this research for the Family Violence Prevention Fund's recently launched kNOw More initiative that examines the reproductive health consequences of sexual coercion and violence. The analysis uses data from the 2002 National Survey of Family Growth, basing estimates of forced sexual intercourse on a sample of 1,833 females aged 18 to 24.

Report Describing Projects Designed to Prevent First Time Male Perpetration of Sexual Violence (Updated), RTI International, 2008

In 2002, the Centers for Disease Control and Prevention (CDC) funded RTI International to identify programs designed to prevent first-time male perpetration of sexual violence and to provide evaluation assistance to a subset of these programs. RTI conducted an environmental scan to identify programs in the relatively new field of prevention of first-time perpetration of sexual violence.

The current report provides updated information on 23 of the original 37 programs and adds information on 36 new programs that have been developed since the 2003 report. This report offers a catalogue of programs targeting prevention of first-time male perpetration of sexual violence.
