Topic: What does PREA have to do with me?

The Prison Rape Elimination Act (PREA) was passed by Congress in 2004. The purpose of PREA is to shed light on and address this very common but overlooked issue. PREA directs states to create victim-centered responses to victims of sexual assault while incarcerated and to develop strategies to prevent prison rape.

The Department of Corrections has focused energy on implementing PREA guidelines in Minnesota: all prison staff in the eight adult and two juvenile facilities have been trained on the basics of sexual assault/violence; investigative officers have had specialized 40 hours of training in investigating sexual assaults; facility based SART teams recently spent two days with DOC staff and MNCASA designing their response protocols.

What does this have to do with me? We know that the effects of violence within prisons affects more than the prison environment. The vast majority of MN inmates return to their communities and unaddressed physical and emotional health issues of victimization can be the catalyst for ongoing problems and challenges.

Lydia Newlin, DOC Victim Liaison, and Collin Gau, Minnesota Correctional Facility, St. Cloud, will talk about the culture change that is underway in Minnesota prisons, the work of PREA to date, and the vision for preventing prison sexual assault.

## **6. The Source to Stop "Booty Ads"**

'THE SOURCE' TO STOP 'BOOTY ADS': Hip hop magazine bans porn and escort advertisements. (January 21, 2009) <http://www.eurweb.com/story/eur50255.cfm>

Hip hop magazine The Source has announced that it will no longer run ads for pornographic movies,

adult web sites or escort services.

So-called "booty ads" featuring scantily-clad women are being banned from the Source's pages and its web site. "I realize the risk that we're taking. (But) we don't want to just glorify the lowest-hanging fruit," co-publisher L. Londell McMillan told the New York Times. "There's a lot of people that want hip-hop but don't want some of the filth that some of the business carries with it."

McMillan said that The Source should be able to appeal to core hip-hop fans and still be a magazine that "you wouldn't mind your kids seeing."

## **8. Recommendations from the Family Violence Prevention**

## Fund

Many organizations are working with the Obama “transition team” members to offer recommendations for action in the next few years. The Family Violence Prevention Fund has released a detailed memo offering a series of recommendations.

The Family Violence Prevention Fund is recommending that the Obama Administration:

- \* Focus on primary prevention that engages men and boys;
- \* Increase early interventions for children exposed to violence that support the health and care-giving ability of all family members;
- \* Target resources to youth and teens;
- \* Fully fund services for victims of violence, particularly as economic conditions increase need;
- \* Address family violence experienced by military personnel/veterans and their families;
- \* Ensure that health care reform includes training, education and research to address the health effects of violence and abuse and funding to implement best practices;
- \* Recognize and address the particular challenges faced by immigrant and refugee victims of intimate partner violence; and
- \* Make ending violence against women and girls a foreign policy priority.

The Minnesota Coalition Against Sexual Assault (MNCASA) is a membership organization that supports the work of 70 sexual assault programs statewide. Our membership also includes groups and individuals that serve victims of sexual assault and work to stop sexual violence.

MNCASA was organized in 1978 as a project of the Minnesota Department of Corrections' Program to End Sexual Violence and incorporated as an independent, nonprofit corporation in 1982. MNCASA is committed to ending sexual violence through cross-disciplinary collaborative partnerships, systemic change, and serving as a voice for victims and survivors, sexual assault programs and



Minnesotans who share our goal to end sexual violence.

Description of Position:

MNCASA received a grant from the Office of Justice Programs (Violence Against Women Act funds) to collaborate with the National Judicial Education Program (NJEP) of Legal Momentum and local partners to develop Minnesota-specific material for NJEP's new free web course for judges and other criminal justice system professionals entitled Intimate Partner Sexual Abuse: Adjudicating this Hidden Dimension of Domestic Violence (available at [www.njep-ipsacourse.org](http://www.njep-ipsacourse.org)).

The position will be responsible for managing this project and will be supervised by the MNCASA Staff Attorney. Duties include implementing work plan with partners, organizing and receiving guidance from an advisory group, thoroughly researching and writing content, maintaining records for grant reporting, publicizing the completed resource, supervising a law student intern, and other project-related activities as assigned.

Experience and Qualification Requirements:

Applicants must be admitted to practice law in Minnesota. Knowledge of the current state of sexual assault and domestic abuse law in Minnesota, as well as strong research experience, is required, and experience as a prosecutor is a plus. Applicant should have excellent communication, analytical, and writing skills as well as a willingness to work collaboratively with a variety of partners in the criminal justice and advocacy systems. Applicant should have a strong commitment to eradicating sexual violence and demonstrate knowledge of its root causes, including sexism, racism, heterosexism, classism, and other systems of oppression.
