## **3. Zumba® with a Purpose, April 18, 2009**

Zumba® with a Purpose, April 18, 2009

We all want our children to grow into happy, healthy adults who experience safe relationships. In most cases, this happens. But in 2005 more than 61,000 MN children and adults were sexually assaulted. Of those affected, 80% were female and 29% were under the age of 18. Sexual assault in Minnesota cost more than \$8 billion in 2005...about three times more than costs related to drunk driving. (Costs of Sexual Violence in MN, MN Dept. of Health)

The Sexual Assault Action Team (part of the Alliance for a Violence-free Anoka County) wants to bring more community involvement to this issue. On Saturday, April 18, as part of Sexual Assault Awareness month, the Sexual Assault Action Team will host their first fundraiser, "Zumba® with a Purpose". Set at the Andover Community Center, participants will be invited to Zumba® at their own

pace. For those who are not familiar with Zumba®, it's Latin music that makes you want to move even if you don't know how to dance. Dancing is not a requirement ...just a desire to move! And on April 18 we will be moving for a purpose” explains Darcy Fox, a Zumba® instructor and a member of the Sexual Assault Action Team. Money raised will be used to fund the action team's educational efforts and enhance services for Anoka County victims of sexual violence. ## **4. Cyberbullying: Tools and Tips for Prevention and Intervention: a Stop Bullying Now! Campaign Webcast, April 22, 2009**

The U.S. Dept. of Health and Human Services, Health Resources and Services Administration (HRSA) through the Maternal and Child Health Bureau (MCHB) invites you to attend a webcast entitled: “Cyberbullying: Tools and tips for prevention and intervention: A Stop Bullying Now! Campaign” on April 22, 2009, 3.00-4.30 EST p.m.

At this webcast, experts in the field of bullying prevention will discuss cyberbullying - an emerging phenomenon among youth. Traditionally, bullying has involved actions such as hitting, punching, teasing, name-calling, or intimidation. In recent years the popularity of technology has given children and youth a new means to bullying each other.

Cyberbullying is a serious problem. 18 percent of students in grades 6-8 said they had been cyber

bullied at least once in the last couple of months; and 17 percent of 6-11 year-olds and 36 percent of 12-17-year-olds reported that someone said threatening or embarrassing things about them through e-mail, instant messages, web sites, chat rooms, or text messages.

The presenters will be: Susan Limber, professor and bullying prevention researcher from Clemson University; Patti Agatston from Prevention/Intervention Center of Cobb County School District, co-author of "Cyber bullying: Bullying in the digital age"; Mike Tully, attorney and expert on legal and policy issues concerning cyberbullying; and Captain Stephanie Bryn from Maternal and Child Health Bureau.

Stop It Before It Starts: Preventing Sexual and Domestic Violence

The U.S. Violence Against Women Act of 2005 states that "nearly 1/3 of American women report physical and sexual abuse by a husband or boyfriend at some point in their lives".

Why are so many sweet little two year old boys growing up to be abusive males? What in the environment supports this kind of behavior? How has this harm become so rampant, so "normal", in our society?

Come to a daylong training that provides some answers on sexual and domestic violence, its causes, and what you can do in your workplace, school, and community to stop it before it starts. There will

Are We Making A Difference?

For those who must confront the seemingly endless consequences of sexual violence (SV) in our society, it is difficult to tell if we're making any headway on the primary prevention side of the equation. How can we tell if progress is being made, when we're daily confronted with a never-ending flow of victims and perpetrators? Is SV increasing or decreasing? Is SV getting worse in Minnesota, in spite of all that we're doing?

Say what?

To address these questions we will present the temporal trends of sexual violence in Minnesota from five data sources— reports to police, arrests, hospital treatment, student survey, & crime survey. Our data suggests to us that SV may be decreasing in Minnesota. This should be good news.

But so what?

It appears that the utilization of services associated with SV is at best constant over time, and may be increasing. Our data suggests that SV is a contributor to the rapidly rising cost of Minnesota's health care system, as is evident from the rising cost of SV treatment.

And now what?

We're desk jockeys who stare at computer screens all day, crunching numbers. Using the DIKA model (Data -> Information -> Knowledge -> ACTION), we need your insight and ideas in translating data into action.

## **11. MNCASA takes bold stand against pornography industry!**

MNCASA takes bold stand against pornography industry!

At its meeting in September, 2008, the Board of the Minnesota Coalition Against Sexual Assault unanimously ratified a policy change that requires MNCASA to prioritize using hotels that do not trade in pornography as sites for official organizational business. By taking this action, MNCASA acknowledges the harm that is caused by sexually degrading/pornographic images of women, men, and children. MNCASA adopted this as another strategy to interrupt the multi-billion dollar business that contributes to the rape culture, the normalization of sexual harm, and that fuels violence using sex.

This new policy directs MNCASA staff, board and volunteers when traveling on official MNCASA business to inquire if a potential lodging site is “clean,” e.g., does not provide in-room pornography for purchase or viewing. While it may not be possible in all circumstances to find alternative lodging if this is not a “clean hotel,” we believe that by simply requesting this lodging option and making a conscientious consumer decision we are refusing to condone the marketing of women, children and men.

MNCASA challenges others to adopt a similar organizational policy. By taking action, we can let the hospitality industry know what will speak to our values as consumers. A collective voice has always proven to be a powerful force in moving social justice efforts forward.

## **12. Minneapolis steps up new anti-prostitution efforts!**

City Steps up New Anti-Prostitution Efforts

Anti-john billboards include a new web address where the public can view arrestee mug shots: [www.johnspics.org](http://www.johnspics.org).

Electronic billboards and tougher prosecution are two ways Minneapolis is getting tough on people who try to solicit prostitutes in the city. Clear Channel Communications is donating space on electronic billboards to send a clear message to would-be johns. The billboards feature a blurred

mug shot and a reminder that Minneapolis now posts photos of people arrested for soliciting prostitutes on its website, [www.johnspics.org](http://www.johnspics.org).

“Prostitution harms the family and the entire community,” said Ninth Ward City Council Member Gary Schiff, who came up with the idea for the billboards and expanded website. “To those who come into Minneapolis looking for a prostitute, these billboards send a message loud and clear: You will be caught and your neighbors, your coworkers and your family will find out.”

The Minneapolis City Attorney’s office has recently changed its prosecution standards to get tougher on johns. City attorneys will now seek convictions on all those who solicit prostitutes in Minneapolis , including first-time offenders. Previously, johns who were first-time offenders in Minneapolis would complete a restorative justice and education program as part of their probation to prevent a conviction from appearing on their record. Under the new plea standards, johns will still complete a restorative justice and education program, but their criminal record will now include a conviction. Restorative justice programs work with criminals to understand the personal accountability of their crimes and how it impacts the community.

“Prostitution is not a victimless crime,” said City Attorney Susan Segal. “Street prostitution damages our neighborhoods and the prostitutes themselves often are as much victim as offender. To further combat this problem we are strengthening our focus on the demand side of the prostitution equation—the johns. With our new, tougher plea bargaining standards, we want johns to know there are real consequences for their actions. We’re also seeking legislative changes to make clear that prostitution activity involving vehicles on the street is a gross misdemeanor crime. We want the word to get out that soliciting prostitution is not okay in our city, on our streets, or in our neighborhoods.”

The Minneapolis Police Department will continue to conduct “john stings” in areas where prostitution has been a problem. According to Third Precinct Inspector Lucy Gerold, “Our aggressive enforcement efforts have not been enough to change this behavior. We need a campaign like this that tells everyone that these are family neighborhoods and not the marketplace for prostitution.”

## **13. New Book: Combating Violence and Abuse of People with Disabilities: A Call to Action**

Combating Violence and Abuse of People with Disabilities: A Call to Action is a new book by Nancy M., Ph.d. Fitzsimons, a professor at Mankato State University who participates in MDH Sexual Violence Prevention Action Teams. The book, published by Brookes Publishing, costs \$25.51 from

People with disabilities are four to ten times more likely to experience violence and abuse, including sexual abuse, than those without disabilities. This book empowers everyone -- professionals, families, and self-advocates alike -- to solve and prevent this problem. It tells how to help people with disabilities learn concrete ways to arm themselves against violence and abuse. It also helps concerned people learn to identify situations that might make a person vulnerable, recognize the indicators of abuse and financial exploitation, and take appropriate action. The book presents ways to eliminate personal, societal, and organizational barriers that perpetuate violence and abuse and make the most of supportive services and systems.

## **14. New Report: False Reports: Moving Beyond the Issue to Successfully Investigate and Prosecute Non-Stranger Sexual Assault**

End Violence Against Women International (EVAWI) staff co-authored a new article entitled: False Reports: Moving Beyond the Issue to Successfully Investigate and Prosecute Non-Stranger Sexual Assault.

The article begins by reviewing up-to-date research suggesting that the rate of false reporting for sexual assault is in the range of 2-8%. It also critiques prior research suggesting that the rate of false reporting is far higher, and explores the reasons why this issue is so challenging for professionals in the field.

Questions addressed in the article include the following:

How many sexual assault reports are false?

What is the actual definition of a false report?

But what if part of the report is false?

The article concludes with a discussion of how professionals can work to overcome these challenges, and how to handle the frustrating reality of "real" false reports.
