Topic: Are We Making A Difference?

For those who must confront the seemingly endless consequences of sexual violence (SV) in our society, it is difficult to tell if we're making any headway on the primary prevention side of the equation. How can we tell if progress is being made, when we're daily confronted with a never-ending flow of victims and perpetrators? Is SV increasing or decreasing? Is SV getting worse in Minnesota, in spite of all that we're doing?

Say what?

To address these questions we will present the temporal trends of sexual violence in Minnesota from five data sources—reports to police, arrests, hospital treatment, student survey, & crime survey. Our data suggests to us that SV may be decreasing in Minnesota. This should be good news.

But so what?

It appears that the utilization of services associated with SV is at best constant over time, and may be increasing. Our data suggests that SV is a contributor to the rapidly rising cost of Minnesota's health care system, as is evident from the rising cost of SV treatment.

And now what?

We're desk jockeys who stare at computer screens all day, crunching numbers.

Using the DIKA model (Data -> Information -> Knowledge -> ACTION), we need your insight and ideas in translating data into action.

### **3. Stop It Before It Starts: Preventing Sexual and Domestic Violence Regional Trainings, April and May 2009**

Stop It Before It Starts: Preventing Sexual and Domestic Violence

Presented By: Minnesota Men's Action Network: Alliance to Prevent Sexual and Domestic Violence

The U.S. Violence Against Women Act of 2005 states that “nearly 1/3 of American women report physical and sexual abuse by a husband or boyfriend at some point in their lives”.

Why are so many sweet little two year old boys growing up to be abusive males? What in the environment supports this kind of behavior? How has this harm become so rampant, so “normal”, in our society?

Come to a day-long training that provides some answers on sexual and domestic violence, its causes, and what you can do in your workplace, school, and community to stop it before it starts. There will be 5 regional trainings on:

This training will provide an overview of the problem of sexual and domestic violence in the morning sessions and then move to primary prevention solutions and action planning in the afternoon.

To this end, a collaborative effort between the MDH, Men As Peacemakers in Duluth and the Gender Violence Institute in Clearwater has been created to develop a network of men and male leaders involved in primary prevention practices. Current efforts are being supported by MDH, the Bush Foundation, the MN Department of Public Safety and Safe Haven Shelter in Duluth.
