### **4. Free on-line training: Vulnerable Adult Mandated Reporter**

The Minnesota Department of Human Services announces a free on-line training on Vulnerable Adult Mandated Reporting. This training is for mandated reporters such as county workers, care providers, law enforcement and health care professionals. Participants will:

- 1) know who is a mandated reporter,
- 2) understand what constitutes maltreatment,
- 3) know when and how to contact the Common Entry Point to make a vulnerable adult maltreatment report, and
- 4) understand the Vulnerable Adults Act.

### **5. New MDH Champions Initiative Invites Minnesotans to Act to Prevent Sexual Violence**

The MDH Sexual Violence Prevention Program and a host of public and private partners have developed a statewide strategic plan which includes strategies reaching all levels of society, from individual knowledge through public policy.

Minnesota Champions...Working Together to Prevent Sexual Violence is a new initiative from MDH, building on Commissioner Jim McDonough's leadership in Ramsey County, creating a prevention plan and adopting a county resolution to end sexual violence. Additionally, Commissioner McDonough, who is also president of the Association of Minnesota Counties, sent a letter to all county commissioners, encouraging all Minnesota counties to take action to prevent sexual violence.

## 6. National Prison Rape Elimination Commission Report

From the National Sexual Violence Resource Center: This final report of the the National Prison Rape Commission, June 2009, proposes standards to prevent, detect, respond to and monitor sexual abuse of incarcerated or detained individuals throughout the United States.

Nine findings are discussed regarding the problems of sexual abuse in confinement and select policies and practices that must be mandatory everywhere to remedy these problems. It also covers recommendations about what leaders in government outside the corrections profession can do to support solutions.
