Risk and Protective Factors of Adolescent Pregnancy, Laurel Edinburgh and Andrea Mayfield

The goal of this report is to inform parents, social workers, probation officers, health care providers, etc. about the unique role sexual violence plays in increasing the risk of unplanned teen pregnancy.

Sexual abuse is not uncommon. In Minnesota, 22% of girls and 9% of boys report abuse. Extra-familial abuse is 3 times more common than incest.

## 8. Article: Feds Undercounting Rape Victims, Advocates Warn

Washington (CNN) -- Are law enforcement officials producing misleading statistics on the prevalence of rape in America? Yes, victims' advocates warn.

Sen. Arlen Specter, D-Pennsylvania, who convened a hearing Tuesday on the "chronic failure to report and investigate rape cases," agrees. Specter also indicated during the Senate Judiciary subcommittee hearing that he would push for change.

At issue is the FBI's 2009 annual crime report -- released Monday -- which shows the total number of forcible rapes in America declining 2.6 percent compared with 2008 and 6.6 percent compared with 2005. There were slightly over 88,000 forcible rapes last year, the FBI estimated.
