The Women's Human Rights Film Series, presented by The Advocates for Human Rights and The Friends of the Saint Paul Public Library, screens *Playground*, Libby Spears' sensitive investigation into the world-wide issue of the sexual exploitation of children.

Executive produced by George Clooney, Grant Heslov, and Steven Soderbergh, and punctuated with poignant animation by Japanese pop artist Yoshitomo Nara, *Playground* illuminates a sinister industry of unrecognized pervasiveness. Spears has crafted a comprehensive revelation of an unknown epidemic, essential viewing for any parent or engaged citizen.

A number of key Minnesota organizations are coming together to sponsor a day-long conference entitled, "Minnesota Summit on Bullying: Evidence-based Practices that Work!"

The summit will cover such important topics as bullying, cyber bullying, school bus bullying, the relationship between bullying and suicide prevention, and other forms of relational aggression, such as dating violence. It will focus on what research has shown to be best practices in addressing these issues and will provide practical tools and strategies that will be helpful to educational professionals in their daily work. The presentations will be given by leading experts in the field nationally.

The summit is designed for a wide variety of school professionals including school administrators, counselors, psychologists, social workers, nurses, resource officers, teachers, school transportation leaders, and community health providers.

### Adverse Childhood Experiences Reported by Adults — Five States, 2009

Adverse childhood experiences (ACEs) include verbal, physical, or sexual abuse, as well as family dysfunction (e.g., an incarcerated, mentally ill, or substance-abusing family member; domestic violence; or absence of a parent because of divorce or separation). ACEs have been linked to a range of adverse health outcomes in adulthood, including substance abuse, depression, cardiovascular disease, diabetes, cancer, and premature mortality (1–3). Furthermore, data collected from a large sample of health maintenance organization members indicated that a history of ACEs is common among adults and ACEs are themselves interrelated (4).
