## 10. Governor Dayton signs the Safe Harbor Bill

The Advocates for Human Rights welcomes the July 20, 2011, enactment of a new approach to protecting children from sexual exploitation. As part of the negotiated budget agreement, Minnesota Governor Dayton signed into law provisions which take significant steps toward building a victim-centered model for protecting children exploited through prostitution.

The measure, introduced earlier this year by a bi-partisan group of legislators, clarifies that sexually exploited children are crime victims, not criminals. "It took an unprecedented show of cooperation between service providers, advocates, law enforcement, prosecutors, and survivors to make this happen. It also took a strong bi-partisan legislative effort in a highly divided session. We're tremendously excited to see everyone come together to protect commercially sexually exploited children in our state," says Jeff Bauer, Director of Public Policy for The Family Partnership.

## 13. Back to School: College Sexual and Dating Violence

As fall approaches, many of us begin to turn our energy to educational pursuits – whether we are going back to school after summer break, supporting children who are returning to school, or considering ways to broaden our professional



knowledge through continuing education.

While college campuses certainly provide opportunities for those seeking academic success, we must also recognize the potential risks that students in this environment may face. College students experience sexual and dating violence at staggering rates and face unique obstacles in accessing services to escape an abusive relationship.

Break the Cycle's The Safe Space offers a wealth of resources and information on College Dating Violence and SAFER (Students Active for Ending Rape) provides information for engaged students interested in effecting social change in schools and on campuses. The organization provides an online library of resources, program mentoring, and keeps a policy database: the Campus Accountability Project. With regard to legal remedies, the NSVRC provides guidance on Title IX of the Education Amendments of 1972, and Break the Cycle outlines the responsiveness of state laws to the unique needs of teens and young adults.

## 14. Article: "The Effects of Victimization on Subsequent Sexual Abuse: Age Matters"

"The Effects of Victimization on Subsequent Sexual Abuse: Age Matters", by Steven Bengis, David S. Prescott, and Joan Tabachnick.

This month's research article looks at the impact of sexual abuse on the development of sexually abusive behaviors in adolescents in different age groups. The research asks the provocative question, does age matter? This initial study showed a correlation for those who were sexually abused between the ages of 3 to 7. This is not a causal risk factor, but it does possibly point to the particularly potent impact of trauma during the age where most children learn to control impulses, begin to regulate their emotions, and develop the frontal lobe capacity to mediate between impulse and action. If nothing else, this article points to the importance of understanding child development and the impact of trauma on that process.
