5. United States: New Study Links Childhood Trauma and Chronic Illness in Adulthood

The Adverse Childhood Experiences (ACE) Study recently reported a strong connection between childhood trauma and the risk of health problems in adulthood.

The ACE study looked at categories of adverse experiences, like abuse, neglect, and household dysfunction, that 17,000 adults had in their first eighteen years of life. The results show that childhood trauma leads to a high risk of adult chronic depression, especially in women.

Alcoholism, coronary artery disease, and suicide attempts are all positively correlated with early traumatic experiences. High scores on the ACE scale also led to an almost 20 year reduction in life expectancy.

According to the study, the connection is especially high for childhood victims of sex or labor trafficking. This is due to the disproportionately high rates of emotional, physical, and sexual abuse that the trafficked persons experience. The ACE study further supports that there are long lasting psychological and physiological effects to the trafficking of minors. See:

7. "Going to Court in Minnesota" Video

The State Court Administrator's Office (SCAO), Court Interpreter Program, has contracted with ECHO Minnesota to produce four 30-minute videos introducing important information about going to court for Minnesota's Somali, Hmong, Spanish and English speaking communities.

"Going to Court in Minnesota," is a half-hour video designed to help immigrants, refugees, and others better understand the Minnesota court system. It is provided in four languages: English, Hmong, Somali, and Spanish. Each video is subtitled in English. The program features judges, court employees, and community advocates explaining various aspects of the judicial process and cultural differences.

9. Human Trafficking: A Public Health Perspective on a Human Rights Issue

(New York)

Lauren Pessio, LMSW, MPA, Director of the Human Trafficking Program, My Sisters' Place, and Christa M. Stewart, Esq., Coordinator, NYS Human Trafficking and Unaccompanied Children Programs, Bureau of Refugee & Immigrant Assistance/OTDA

Human trafficking has often been referred to as "modern day slavery." The Trafficking Victims Protection Act of 2000 defines human trafficking as recruiting, abducting, facilitating, transferring, harboring, or transporting a person, by threat or use of force, fraud or coercion, for the purpose of subjecting that person to involuntary servitude, peonage, slavery, slave-like practices, commercial sex, or forced or bonded labor services. According to federal law, any person under the age of 18 years old induced to perform a commercial sex act is considered a victim of human trafficking, whether force, fraud or coercion are present or not.

Victims of human trafficking often suffer from a variety of health issues including malnourishment, STIs and other gynecological issues, exposure to communicable diseases, chronic conditions including vision, back, hearing, and respiratory problems, dental issues, and a host of disorders related to psychological trauma.

Unfortunately, victims of human trafficking frequently remain unnoticed or unassisted. This webcast will provide the public health workforce with an overview of human trafficking as well as insights on how to detect it and what actions to take if there is suspicion of trafficking.
