- ▶ Public Policy
- ▶ Family communication and support for youth
- ▶ Male involvement and responsibility

**Background information**

Regular meetings for this group began in the Spring of 1999 as an advisory committee to the Saint Paul Teen Pregnancy Project, convened by the Minnesota Organization on Adolescent Pregnancy, Prevention and Parenting (MOAPPP), in partnership with the Saint Paul - Ramsey County Department of Public Health. Initial project goals were to:

- ▶ Increase service coordination and collaboration
- ▶ Increase public awareness
- ▶ Provide learning and training opportunities for persons working with youth
- ▶ Work on policy change

A great deal has happened since those earliest meetings! In the Fall of 2000 several committee members urged the committee to pay more attention to how sexual violence and teen pregnancy are critically linked.

The committee set out on an educational process to learn more about the intersection of these issues and what it would mean for our work with youth - males and females. Over time, the committee was convinced that a focused effort was needed. That led to creative partnerships in 2001 and 2002 with the Sexual Violence Action Team. In early 2003, the 2 groups merged and the project's goals evolved.

The TPP/SVAT was formed to:

- ▶ Decrease isolation of persons working on teen pregnancy and sexual violence issues in Ramsey County communities
- ▶ Increase their access to best practice information and culture specific resources
- ▶ Increase public understanding of teen pregnancy and sexual violence issues and effective prevention
- ▶ Improve public policy related to teen pregnancy and sexual violence issues

Over the years the committee evolved into a coalition. Since 1999, very diverse assortments of more than 75 organizations that work with youth and families have had active staff involvement in the project. The project has worked in a variety of ways to understand teen pregnancy and sexual violence in the context of promoting healthy youth development.

In 2003-2004, the project's objectives were to:

- ▶ Develop, and expand the coalition and members' opportunities for capacity building and leadership development
- ▶ Increase use of culturally responsive, culturally appreciative practices
- ▶ Increase community awareness and understanding of teen pregnancy and sexual violence issues
- ▶ Promote family communication about sexuality and healthy relationships
- ▶ Raise awareness about teen pregnancy and sexual violence being issues that involve males and females and require males, as well as females to be part of the solutions
- ▶ Promote teen health services
- ▶ Encourage schools to implement effective comprehensive sexuality education

## 4. Grants Alert

**Department of Justice Office on Violence Against Women  
Legal Assistance for Victims Grant Program (CFDA No.: 16.524)**

**Purpose**

To increase the availability of legal assistance necessary to provide effective aid to victims of domestic violence, dating violence, stalking, or sexual assault who are seeking relief in legal matters arising as a consequence of that abuse or violence.

**Deadlines**

- ▶ An optional letter of intent is due January 4, 2005.
- ▶ Online Grant Management System register deadline: January 11, 2005
- ▶ Online application deadline: 5:30 pm (EST) January 25, 2005
- ▶ Hard copy application (via overnight delivery) deadline: January 25, 2005

**Eligible Applicants**

- ▶ FY 2003 grantees
- ▶ recipients of FY 2000 and 2002 funding who did not receive an FY 2004 continuation award
- ▶ previously unsuccessful applicants and new applicants (examples of the latter include law school legal clinics, domestic violence victims' shelters, bar associations, sexual assault programs, private nonprofit entities, Indian tribal governments, legal aid or statewide, faith and/or community-based legal service providers).

All applicants must certify that they are in compliance with the statutory Requirements as listed on page 3 of the Fiscal Year 2005 Solicitation.

**Estimated Available Funds**

Not determined yet.

**Maximum Size of Award**

Between \$450,000 and \$850,000, depending on size of area served.

**Estimated Number of Awards**

Not determined yet.

**Project Period**

24 months.

***S\*T\*O\*P\* Violence Against Indian Women Discretionary Grant Program (CFDA No.: 16.587)***

**Purpose**

To encourage tribal governments to develop and strengthen the tribal justice system's response to violence against Indian women, and to improve the services available to victims of domestic violence, sexual assault, and stalking.

**Eligible Applicants**

Must meet the following four criteria

- ▶ Federally-recognized tribal government or consortium of tribal governments
- ▶ propose project activities that fall within the scope of one or more of the statutory program purpose areas
- ▶ collaborate with a non-profit, non-governmental victim services provider
- ▶ certify that they meet VAWA certification requirements

**Maximum Size of Award**

Up to \$150,000 for new applicants and up to \$350,000 for continuation awards.
