## **5. Two articles from SafetyLit listserv**

[SafetyLit](#) listserv is a source for recent research about injury prevention. Information about the occurrence and prevention of injuries is available from many sources and disciplines. [SafetyLit](#) staff and volunteers regularly examine more than 500 journals and scores of reports from government agencies and organizations. Each week [SafetyLit](#) online abstracts are read by 41,000 people from

172 nations.

*Lessons Learned and Unanswered Questions About Sexual Assault Perpetration*

Antonia Abbey, Wayne State University.

The most important lesson learned about interpersonal violence in the past 20 years is the astonishingly high prevalence of sexual assault in American society. The extensiveness of unreported sexual assault has been repeatedly documented through the use of self-report data from well-constructed surveys of victims and perpetrators. In contrast, little has been learned about how to effectively reduce rates of sexual assault perpetration. Theoretically derived universal prevention programs targeted at adolescents are sorely needed. [ [Full text](#)]

*Lessons Learned from the Last Twenty Years of Sexual Violence Research*

Brian P. Marx, Temple University.

The present article attempts to answer important questions about the most important thing learned from the past 20 years of research on sexual violence, the most important thing to be learned about sexual violence over the next 10 years, and the most promising methodological innovation in the study of sexual violence from the last 20 years. It is hoped that discussion of such important questions might further stimulate researchers and mental health professionals to continue making progress in our understanding of, as well as the struggle against, sexual violence. In the end, as they unveil their journey to recovery, the message is clear: The horrible nature of sex crimes against children cannot be understated. As

parents and protectors of our most valuable resource - children - we must continue our work to save them from harm.

## **8. Human Trafficking and Slavery: Tools for an Effective Response conference, April 7, 2005**

Sexual trafficking of Asian and other minority and immigrant women is of great concern in many of

the Asian and Southeast Asian communities in Minnesota - including Korean, Chinese, Filipino and Hmong. The Human Services Department encourages Asian/SW Asian agency staff, directors, front line case workers, social workers, health care providers, and legal service providers register to take part and benefit from this excellent training.

Slavery still exists in the 21st Century and in the U.S. In Minnesota, a young Nigerian woman recently filed a federal civil suit stating that she was subjected to trafficking and domestic servitude. A federal criminal investigation is pending.

Learn more about the dynamics of human trafficking and how to work together to combat this issue in Minnesota communities.

Human trafficking victims are smuggled and subjected to forced prostitution, domestic servitude and child labor, among other human rights abuses.

This training provides an overview of US anti-trafficking laws and regulations, case referral and management. The course is designed for law enforcement, social service providers, health care providers and legal service providers.
