## ***8. Understanding Child Sexual Abuse: Education, Prevention, and Recovery***

The American Psychological Association has recently created, [Understanding Child Sexual Abuse: Education, Prevention, and Recovery](#). What are the Effects of Child Sexual Abuse? There is no universal definition of child sexual abuse. However, a central characteristic of any abuse is the dominant position of an adult that allows him or her to force or coerce a child into sexual activity. Children and adolescents who have been sexually abused can suffer a range of psychological and behavioral problems, from mild to severe, in both the short and long term.

## **10. From Bullying to Battering: Building Partnerships for Safe Schools**

Join national experts for a two-day seminar from June 6 to 7 on preventing dating violence, sexual assault, sexual harassment and bullying in K-12 schools. [The 5th annual \*From Bullying to Battering\*](#) seminar is designed to promote effective violence prevention strategies through partnerships between schools and community-based agencies. This seminar is designed for educators, counselors, domestic violence and sexual assault center advocates, law enforcement officers and others involved in promoting positive relationships among youth.

Featured speakers include Patrick Lemmon and Nigel Okunubi from Men Can Stop Rape, an organization in Washington D.C. that is nationally recognized for its leadership in the field of sexual assault prevention; Rita Noonan, a behavioral scientist with the Centers for Disease Control and Prevention; and Barri Rosenbluth along with members of the Expect Respect team at SafePlace - the Expect Respect program provides comprehensive services in collaboration with local schools to prevent dating violence, sexual harassment and bullying. As partners in a sexual violence prevention evaluation project, Rita, Patrick and Barri will share results, methods, and tools for evaluating violence prevention programs.

### Seminar Topics:

- ▶ Empowering young men to prevent men's violence by becoming visible allies.
- ▶ Developing school policy and procedures for preventing dating violence, sexual harassment and bullying.
- ▶ Responding to violence and abuse in children's lives through school-based counseling and support groups.
- ▶ Utilizing a public health framework to strengthen prevention programming.
- ▶ Integrating prevention curricula into classroom lessons for students in grades K-12 as well as strategies for educating teachers and parents.
- ▶ Promoting youth leadership in violence prevention through student-driven campaigns, research, art and theater, and more.



- ▶ Evaluating the impact of prevention on students' attitudes, knowledge and behavior as well as overall school safety and climate.

The two-day seminar will host a diverse group of participants from K-12 schools, sexual assault and domestic violence organizations, and public health agencies.

### **Featured Speakers**

Luoluo Hong, Ph.D. is an activist and educator and is the dean of students at the University of Wisconsin-Madison, and a traveling speaker and educational consultant with the Denver-based agency Campuspeak. Hong has delivered lively keynote speeches at numerous regional and national conferences, and her dissertation results have been published in the Journal of American College Health. She also authored a chapter in the book *Just Sex*, describing her experiences as a rape survivor. Hong is well known in the campus health field and is a past member of the American College Health Association's board of directors. She is currently a member of the board of directors at the Dane County Rape Crisis Center in Wisconsin.

Patrick J. Lemmon is the Executive Director and co-founder of Men Can Stop Rape in Washington D.C. He has been involved in anti-rape education for more than 10 years, conducting hundreds of

workshops and trainings in the metro D.C. area and nationwide. As a highly regarded opinion leader, Lemmon is frequently asked to speak at conferences across the country about the role of men in preventing men's violence against women and has been interviewed by such high profile media as The New York Times, O Magazine, The Washington Times, Pacifica National Public Radio, The Tavis Smiley Show, Details Magazine, and The London Guardian. His master's thesis focused on the social construction of masculinity and the role of men in the anti-rape movement.

Reanae McNeal is a performing artist, award-winning playwright, inspirational speaker, oral historian, storyteller, performance poet, musician, cultural/social activist, and survivor. She is the founder and president of Imani Revelations and Beauty for Ashes Ministries. She has been described as “the woman who transforms lives,” encouraging audiences to be all they are destined to be. McNeal shares valuable life lessons with humor and charisma as she takes her audiences on a journey to take back their power in their life circumstances and situations, sharing her life of tragedy and triumph. McNeal has toured extensively nationally and internationally. McNeal is also an Honorary Board Member of the National Sexual Assault Resource Center.
