## 1. Special Project Funding: Enhancing and Improving Health Care and Public Health Practices Related to Sexual Violence

This request for proposals, [Enhancing and Improving Health Care and Public Health Practices Related to Sexual Violence](#), is designed to solicit applications for special projects to enhance and improve health care and public health practices in response to sexual violence. The intent is to raise awareness of sexual violence within the health care communities, and work with health care providers to become a positive part of the solution.

A total of \$120,468 is available in grant amounts ranging from \$20,000 - \$25,000. This is a one-time special project funding made available through the Minnesota Department of Health, with Prevention Health and Health Service Block Grant funds, for the FY06 12-month grant period of July 1, 2005 -

June 30, 2006.

Applications will be submitted using the [Web-Enabled Grants Operations](#) (WEGO) system.

## **7. The Violence Against Women Act Reauthorization**

The Violence Against Women Act (VAWA) is up for reauthorization this year. As reported in the Fall 2004 issue of the National Center on Domestic and Sexual Violence newsletter, VAWA's passage in 1994 and its reauthorization in 2000 dramatically changed the landscape for victims who previously suffered in silence with limited assistance. Under the leadership of Senator Joseph Biden (D-DE), VAWA has been remarkably effective in moving society in the direction needed to end domestic violence, sexual assault, dating violence and stalking. Reauthorization and expansion of VAWA are the next vital legal steps. Like its predecessors, the 2005 reauthorization has the potential to vastly improve the services and funds available to help victims.

The Youthhood is a project of the [National Center on Secondary Education and Transition](#) (NCSET) at the Institute on Community Integration, University of Minnesota. NCSET provides coordinates national resources, offers technical assistance, and disseminates information related to secondary education and transition for youth with disabilities to all 50 states and the U.S. Territories. NCSET is funded by the Office of Special Education Programs at the U.S. Department of Education through a grant award.

As part of NCSET's sponsored grant activities, Youthhood is provided at no charge as a resource and transition planning tool for teachers, community service providers, parents, guardians, youth with and without disabilities, and anyone else who may benefit from utilizing this site to help youth plan for the transition from high school to adult life.
