The Sexual Violence Justice Institute (SVJI) program of the MN Coalition Against Sexual Assault (MNCASA) encourages the effective and victim-centered investigation and prosecution of sexual assault cases by increasing access to protocols, training and resources. Research shows that only 16 percent to 20 percent of sexual assault victims turn to the criminal justice system for help. For a variety of reasons, victims have not seen the traditional system as a viable option. It is the MNCASA goal to work together with community professionals to stop this trend. Dads Make a Difference trains high school teens, male and female, to teach a four-lesson curriculum to middle school-age youth regarding the importance of fathers in families, responsibilities of being a parent, and importance of making good choices about risky behavior so as not to become a parent too soon. Core activities include healthy youth development, healthy relationships, and co-parenting. DMAD will have two trainings this fall for teens from schools and community agencies along with an adult advisor. Cost is \$55 per participant for two-day training in Twin Cities metro area on Nov. 13-14, 2005. Cost is \$45 for one-day intensive training in Mankato on Oct. 24. Sliding fee and scholarships are available if needed. Please call, email or check [DMAD](#) for more information if you work with teens and are interested in training opportunities. DMAD is also taught in juvenile detention settings in the metro area by DMAD staff.
