2. **Teens who experience dating violence at greater risk for STD's**

[**Teens Who Experience Dating Violence at Greater Risk for STDs**](#)

Nearly one in three sexually active adolescent girls (31.5 percent) report experiencing physical or sexual violence from a dating partner, and there is a “significant” association between being a victim of dating violence and being diagnosed with a sexually transmitted disease (STD) or HIV.

Those are among the findings from a study published in the August 2005 issue of *Pediatrics*. *Dating Violence and Sexually Transmitted Disease/HIV Testing and Diagnosis Among Adolescent Females* looks at more than 1,600 sexually active 9th to 12th grade female students who filled out Youth Risk Behavior Surveys in Massachusetts in 1999 and 2001.

Dating violence victims are more likely to be tested for and diagnosed with an STD or HIV than girls who do not experience dating violence, even after accounting for other sexual risk behaviors. In fact, one in 12 dating violence victims reports a sexually transmitted disease, compared to one in 30 girls who do not experience dating violence. Girls who experience dating violence are three times more likely to be tested for an STD and HIV, and 2.6 times more likely to report an STD diagnosis, than girls who do not experience dating violence.

“We are seeing a staggering proportion of teenage girls experiencing physical or sexual violence from dating partners,” Michele R. Decker, MPH, Harvard School of Public Health and one of the study’s authors, told Reuters. “Violence against women has been linked with numerous negative health outcomes, and I think through this study we are seeing further evidence of the tremendous health consequences of this violence.”

Authors recommend further research, and the development of community-based programs that address dating violence and STD/HIV risk. They encourage clinic staff to discuss relationship dynamics with patients and screen them for dating violence, noting that discussions about barriers to using condoms and other contraceptives may prompt patients to disclose dating violence. Medical professionals should make information about dating violence support services available to all patients, regardless of whether they admit to being abused, they say.

Pediatrics is the journal of the American Academy of Pediatrics. In addition to Decker, the study’s authors are Jay G. Silverman, PhD, of the Harvard School of Public Health and Anita Raj, PhD, of the Boston University School of Public Health.

4. How to contribute to the UN Secretary-General's study on all forms of violence against women

On 22 December 2003, the General Assembly of the United Nations requested the Secretary-General to conduct an in-depth [study on all forms of violence against women](#) (resolution 58/185). The goals of the study are to:

- ▶ Highlight the persistence of all forms of violence against women in all parts of the world, and the unacceptability of such violence.
- ▶ Strengthen political commitment and joint efforts of all stakeholders to prevent and eliminate violence against women.
- ▶ Identify ways and means for better and more sustained and effective implementation of Government commitments and obligations to combat all forms of violence against women, and increase accountability.

The study will be completed in June 2006 and presented to the United Nations General Assembly at its 61st session in the fall of 2006. The UN Division for the Advancement of Women (DAW) is responsible for the preparation of the study. A Task Force made up of both NGOs and UN agencies, of which the Center for Women's Global Leadership is a part, has been working closely with the Division for the Advancement of Women to devise ways that NGOs can provide input into the study.

It is important for women's organizations and groups involved in anti-violence against women advocacy and policy development to contribute to the processes related to the study. Please consider the opportunities for input below and engage wherever possible:

- ▶ The DAW has requested written NGO input in the form of brief papers (3 pages maximum) that draw from the organization's experience, flag trends and highlight key issues requiring attention,

and give examples of good practice in combating all forms of violence against women. Please see the NGO Input form for more information on how to submit, and please feel free to pass this invitation through your networks. You may also wish to consult the study outline to inform your input. Input is due to the DAW by 15 October 2005.

- ▶ An online discussion will be held for three weeks, during the last week of September and the first two weeks of October, to increase opportunities for civil society to contribute ideas and recommendations. Please check the study website (<http://www.un.org/womenwatch/daw/vaw/index.htm>) for updates as the dates approach.
- ▶ NGOs on the task force have prepared an NGO Calendar of Events, highlighting events at the regional and international level which will be taking place over the next year and which may provide opportunities to publicize the study and solicit additional NGO input. Interested NGOs who are attending these events, or others related to violence against women, are encouraged to raise awareness of the study at these venues.
- ▶ Also, on 6-7 September 2005, the Division for the Advancement of Women will hold a one and one-half day consultation in New York for representatives from NGOs, Member States and UN entities. All are invited to attend. The purpose of the consultation is two-fold: to highlight the linkages between violence against women and the achievement of the goals of the Millennium Declaration in the lead-up to the 2005 World Summit (which takes place immediately after the consultation), and to provide a forum for Member States, NGOs and UN entities to consult on the study and discuss key issues that require priority attention. Did you have dreams or plans for your children to grow up to be victims of domestic and sexual violence, or to be the perpetrators of these crimes?
