## 2. The Basics on Rape Behind Bars

Prisoner rape is a problem that affects large numbers of men, women, and youth.

A recent study of prisons in four Midwestern states found that approximately one in five male inmates reported a pressured or forced sex incident while incarcerated. About one in ten male inmates reported that that they had been raped.

Rates for women, who are most likely to be abused by male staff members, vary greatly among institutions. In one facility, 27 percent of women reported a pressured or forced sex incident, while in another facility, seven percent of women reported sexual abuse. Youth in detention are also extremely vulnerable to abuse. Research has shown that juveniles incarcerated with adults are five times more likely to report being victims of sexual assault than youth in juvenile facilities, and the suicide rate of juveniles in adult jails is 7.7 times higher than that of juvenile detention centers. As states try growing numbers of juveniles as adults, the risk of sexual abuse increases.

## 4. Position Opening: LICSW Level Therapist/Clinical Supervisor

The Neighborhood Involvement Program (N.I.P.), Rape and Sexual Abuse Center currently has a 20-25 hour a week position opening, which includes benefits. The Rape and Sexual Abuse Center is one of three mental health programs of the Neighborhood Involvement Program. Services include individual and group therapy to adult and adolescent survivors of sexual violence. Treatment focuses on the reduction of symptoms (i.e. depression, anxiety, PTSD) and issues related to relationships, self esteem, sexuality, etc. This position has two areas of responsibility including managing a small caseload of individual clients and supervising the clinical work of social work students.
