## **5. 2006 Training Calendar set for The Minnesota Network on Abuse in Later Life**

In 2006, The [Minnesota Network on Abuse in Later Life \(MNALL\)](#) is sponsoring training and information exchanges in nine Minnesota communities. The workshop program, *Building Community Partnerships: Promoting Health and Safety in Later Life*, features these meeting objectives:

1. Increase knowledge of domestic violence and sexual assault in later life for all community health care providers and other senior service providers.
2. Identify possible solutions when addressing barriers and challenges faced by victims of domestic/sexual abuse in later life in your community.

Participants will learn about ageism and advocacy, state adult protection services, and the [Adverse Childhood Experiences](#) study which looks at early and current trauma and its relationship to chronic health issues and disease. There will be an opportunity to talk about engaging communities to jointly address issues of abuse in later life.

The workshops are tailored for a wide-range of community stakeholders, including health professionals from hospitals and clinics, local public health agencies, domestic and sexual violence advocates, adult protection personnel, home health care, nursing home personnel, parish nurses, faith communities, social workers, senior service providers, law enforcement, prosecutors and other interested community members.

## **6. Civil Society to Launch Minnesota Human Trafficking Watch**

The Minnesota Human Trafficking Watch is a group of people and agencies who are concerned about the horrific sex and labor trafficking going on in the State of Minnesota. The Watch will coordinate trainings, conduct public education and outreach, and provide comprehensive services to victims of trafficking in the State of Minnesota. The Watch will collaborate with law enforcement to make sure that trafficking victims receive resources they need to be safe.

Minnesota has become one of the 13 most heavily sex and slavery trafficked states in the nation. The 2003 Innocence Lost National Initiative targeted the Twin Cities as one of the 13 cities targeted as a high intensity trafficking area. The U.S. government estimates that approximately 20,000 foreign nationals are trafficked into the U.S. each year. Minnesota is particularly affected by trafficking because we are a border state.

Victims of human trafficking are forced into labor and sexual exploitation. Approximately 50% of all victims of trafficking are children. Sex trafficking is the most lucrative sector of the trade in people. It involves forced, fraud or coercion for the purposes of commercial sex. Trafficking victims are often involved in industries where they are invisible, including domestic servitude, sweatshops, restaurant and hotel businesses, farm work, construction, begging and peddling, the sex industry and servile marriage.
