1. Stop It Now! Minnesota's ad campaign is moving beyond the Twin Cities metropolitan area

As you may know, the Minnesota Department of Health is funding expansion of Stop It Now! Minnesota's ad campaign beyond the Twin Cities metropolitan area. Funding is from Minnesota's Rape Prevention and Education grant from the National Centers for Disease Control and Prevention which is part of the federal Violence Against Women Act reauthorized in 2005.

Stop It Now! Minnesota is initially focusing the ad campaign on four communities: St. Cloud, Brainerd, Duluth, and Mankato. These locations were selected because they have treatment providers who have been trained to accept referrals from the Stop It Now! helpline from people who are concerned about their own sexual thoughts or behaviors towards children. This is important because the target audience for the ads is adults concerned about themselves.

In partnership with the Minnesota Coalition Against Sexual Assault, Prevent Child Abuse Minnesota, and Survivors Network Minnesota, Stop It Now! Minnesota is holding community meetings with professionals from these communities and the surrounding area. The focus of the meetings is to

introduce Stop It Now! Minnesota, provide background and previews of the ad campaign, and seek input on Stop It Now! Minnesota's strategic five-year plan. Each meeting is also sponsored by local organizations including sexual assault programs, child abuse prevention councils, etc.

Manager of Community Assistance

Jacob Wetterling Foundation, St. Paul, MN

Agency Description: When a child is exploited or goes missing, it becomes an issue of public safety and public health. Most families are not equipped to handle the situation alone. They need the help of an experienced organization who can guide them through the insidious nature of these crimes and to help find the best methods for resolving such a traumatic situation. There are multiple agencies and contacts, often accompanied by zealous media in a short period of time. [Jacob Wetterling Foundation](#) (JWF) is a private, non-partisan, non-profit 501(c)(3) agency established in 1990.

The organization collaborates with families, communities, public policy makers, state and county agencies, law enforcement and the media to assist missing and exploited children in communities throughout Minnesota. The organization's focus is to provide prevention education information along with response/support services.

Duties: The Manager of Community Assistance will be responsible for

Responding to victim's assistance calls by providing appropriate guidance and referrals (periodically on-site) to individuals who have experienced a missing and/or sexually exploited child

Case management of new and existing cases

Tag-teaming on existing victim's assistance protocol manual initiatives

The targeting, writing, and tracking related to community assistance grant applications and proposals. Working closely with peer managers to develop resources, budgets, project needs, grant reporting, and evaluation.

Customizing presentation and training materials (e.g. PowerPoints, visual aids) as needed for various audiences

Presenting JWF messages in a public setting, recruiting audiences

Coordinating and tracking related JWF speaking engagements and evaluations

Assisting with the creation and submission of "opinion education" articles for local publications

Working with community partners to represent JWF in a variety of multidisciplinary coalitions

Attending 3 local and regional trainings each year

Qualifications: A Bachelor's degree in public health, social work and psychology is optimal.

Experience in case management or crisis services is required. Familiarity with child sexual abuse prevention programs and services is strongly desired. Previous experience in project management in the non-profit sector is preferred. Flexibility, strong written and oral communication skills, and the ability to multi-task are necessary for this position.

Time Commitment/Salary: Full-time position with benefits. Office hours are Monday-Friday 8:30-4:30pm, with on-call component. Salary is commensurate with experience.
