4. Sexual Assault Nurse Examiner Training, November 14-17, 2006

The Sexual Assault Nurse Examiner (SANE) workshop is an intensive four-day course to familiarize law enforcement, advocates, and nurses with aspects of the forensic and health care processes for adult survivors of sexual assault and intimate partner violence. It emphasizes victim advocacy and the overall importance of being an interdisciplinary team member in the investigative, health care and prosecution process.

This course will be conducted by Linda Ledray, PhD, RN, FAAN, a certified SANE trainer and Director of the Sexual Assault Resource Service (SARS) of Hennepin County Medical Center in Minneapolis, Minnesota. Dr. Ledray is a nationally recognized expert and pioneer in the area of forensic nursing. The program is supported by an array of interdisciplinary expert faculty.

The training will be held on November 14 - 17, from 8:00 a.m. - 5:30 p.m. at the Beltrami Electric Cooperative, 4111 Technology Drive, NW, Bemidji, MN. CEUs will be offered: 33.6 for Nursing, 13 CE Hours for Law Enforcement (first two days).

5. Survey: Silent Injuries

Many professionals and staff whose work, either directly or indirectly, involves child sexual abuse are aware of the potential emotional consequences of working in this field. Robert Emerick, M.Ed., has developed an excellent questionnaire to evaluate the impact these [Silent Injuries](#) have on people who work in this field. [Answering the questionnaire](#) takes approximately 30-45 minutes and it is anonymous.

Some examples of appropriate people to participate in this study are mental health providers and staff, child protection professionals and staff, victim advocates and advocacy center staff, nonprofit organization employees and staff, law enforcement employees and staff, prosecuting and defense attorneys and staff, and probation and parole officers and staff, to name a few. The results of this research will help to better understand the personal impact of working in the child sexual abuse field and define ways to protect and enhance the emotional health of the professionals and staff who do this work.
