## **4. Job Opening: MNCASA Sexual Violence Prevention Coordinator**

Position Objective: To build the capacity of community based programs to develop and implement comprehensive primary prevention of sexual violence initiatives based on the state sexual violence prevention plan.

Position Description: This is a full time position whose primary goal is to organize and build capacity of community-based sexual assault programs, and other related organizations, to understand and prevent sexual assault using the strategies set forth by the state and other guiding organizations. Responsibilities include but are not limited to: providing technical assistance to constituents on primary prevention, learning and communicating hr public health approach to sexual violence prevention; convening sexual violence prevention stakeholders to inform the prevention programming at MNCASA and to provide a forum to share information; coordinate and participate in existing partnerships: Sexual Violence Prevention Network, Sexual Violence Prevention Action Council and Stop It Now! MN; develop and disseminate written materials, curricula and outreach materials.
