MDH Burn Surge Project

According to the American Burn Association (ABA), over 70% of burn injuries are directly tied to home fire incidents, and one civilian fire death occurs every 2 hours and 41 minutes. Treating and stabilizing burn victims is a specialized practice with limited resources under normal day-to-day operations. A small scale mass casualty incident can rapidly escalate from conventional or contingency levels to a crisis level of response.

The MDH Center for Emergency Preparedness and Response has teamed with our 2 ABA verified burn centers (Regions Hospital-Burn Center and Hennepin County Medical Center-Burn Center), 8 regional Health Care Coalitions, and 13 Burn Surge Facilities to develop a statewide burn surge plan that fully integrates local, regional, state and national partners and resources.

On March 8, 2017, MDH launched a statewide Burn Surge roll out event where participants reviewed the recently completed MDH Burn Surge Plan, engaged in a table top exercise, and reviewed burn victim case studies. We had 99 attendees join us (in person and virtually) and participants ranged from medical professionals, emergency medical services, emergency managers and state partners. The day was packed with great discussions, quality feedback on both strengths and opportunities for improvement, and high energy and passion to continue such discussions at the local level.

Statewide partners have since moved forward with additional burn education, exercising and planning efforts. Their dedication and interest in keeping this momentum going is commendable, and will help ensure Minnesota’s burn surge preparedness. What's up with the Workspace?

As referenced in the previous issue of EPR News, plans are underway to ensure a smooth migration to a new Workspace system. A migration team, comprised of MDH and local public health members, is meeting monthly to work through key issues.

Updates for this quarter: The migration team has completed an assessment of the 33 roles currently in use in the Workspace. They are now in the process of clarifying the role titles and updating the role definitions.

As an example, the team realized that there were four separate local public health leadership roles: CHS Administrator, Local Public Health Nursing Director, plus a back-up role for each. Additionally, they noticed a lack of consistency as to which roles were selected when messages were sent. As a result, some local leaders were missing out on important communications some of the time. To improve this situation the team has proposed combining the four roles into two: a Local Public Health Leadership role and a back-up role. Local jurisdictions will be able to select who and how many people to assign to the role to best meet their local needs.

With input from local public health leaders around the state, the migration group has identified another improvement for the new Workspace. The new system will be set up to automatically copy the leadership role on all general messages. This will help ensure that leaders are always "in the know".

SharePoint Migration Update

The MDH SharePoint Migration is finished and it is time for local and tribal health departments to get access to their migrated sites.
