# **From the Director**

# What's up with the Workspace?

As referenced in the Director's update, the Workspace is nearing the end of its life and plans are underway to ensure a smooth transition to a new system. A migration team began meeting in January and has started working through key issues around the directory, documents and messaging.

The migration team includes technical and content experts from MDH programs that frequently push information out via the Workspace, including EPR and IDEPC. The team also includes representatives from local public health who will ensure that the needs and perspectives of end users are taken into account. The team will meet monthly until the migration plan is completed late in 2017. The team will share quarterly updates through this newsletter.

**Updates for this quarter**: A decision has been made to use a software package, called MIR3, to manage the directory and provide messaging services, after the Workspace has been phased out. MIR3 has the advantage of already being in use at MDH. It's known for its reliability, and it has some features that end users may find to be improvements over the Workspace. A key first task of the transition team will be to review the 33 roles currently in use in the Workspace to determine which roles should be carried forward into MIR3.

# **MNTrac System Performance Drill**

During a full-scale exercise MDH conducted in March, the MNTrac system experienced major performance issues which resulted in users being kicked out of the system during the exercise. MDH, along with the MNTrac Advisory Committee worked with the MNTrac software vendor ImageTrend to ensure the different applications throughout the system were optimized to be able to handle the future volume of users and tasks Minnesota health care providers need during system-wide incidents.

Our January 11, 2017 drill was done to test the new improvements to the system, and to attempt to overload MNTrac again so the software vendor could monitor for additional future improvements. We successfully managed to take MNTrac down immediately after over 15,000 devices were issued Alerts.

Thank you to all who helped us test the limits of MNTrac; we were able to get very important information about the system that we can now use to further-enhance MNTrac's capabilities. Although it may have been a frustrating experience during the initial fifteen minutes of the two hour drill, for many, we accomplished what we set out to do.

## Don't forget the bug spray!



Minnesotans are well acquainted with mosquitos, but not in the winter. Yet, many of us travel to warm weather destinations this time of year. Many popular winter travel destinations have documented local Zika transmission. Minnesota reported a substantial number of travel-associated Zika virus cases during 2016. MDH wishes to remind "sun seekers" - *especially pregnant women and couples planning a pregnancy* - to take steps to reduce their risk of becoming infected and prevent Zika associated birth defects .
