4732.#### SERVICE PROVIDER DEFINITIONS.

Note: This document is intended as a reference for the Service Provider focus group. Some of the definitions are already contained in the Definitions part of Chapter 4732. MDH intends to incorporate newly proposed definitions in this document into the Definitions part of Chapter 4732.

Subp. ##. Assemble or assembled. "Assemble" or "assembled" means to fit together the

parts or pieces of an x-ray system or x-ray system components.

Subp. ##. Direct supervision. "Direct supervision" means guidance and instruction by a

gualified expert or a qualified medical physicist who is physically present, is in direct contact

with a service technician, and is able to give immediate assistance.

Subp. ##. General supervision. "General supervision" means services performed under

the overall direction and control of the qualified expert or qualified medical physicist and who is

not required to be physically present during the performance.

Subp. 37. Individual. "Individual" means a living human being.

Subp. ##. Install or installed. "Install" or "installed" means to set up an x-ray system for

use by a registrant where the assembly, adjustments, testing, and tolerances are performed

according to this chapter.

Subp. 52. Person. "Person" means any individual, corporation, partnership, firm,

association, trust, estate, public or private institution, group, agency, political subdivision of this

Subp. 42. Install or installed. Install" or "installed" means deliver, assemble, or place X-ray equipment or X-ray machines so that the machines and equipment are: (1) in a registrant's possession; and (2) ready for use by a registrant.

state, and any legal successor, representative, agent or agency of the foregoing, excluding federal government agencies.

Subp. ##. Qualified expert. "Qualified expert" means an individual who meets the qualifications under part 4732.####.

<u>Subp. 58.</u> **Qualified medical physicist or QMP.** "Qualified medical physicist or QMP" means an individual who meets the qualifications under part 4732.#### and is trained in evaluating the performance of CT or interventional fluoroscopic x-ray systems.

Subp. ##. Responsible individual. "Responsible individual" means an individual who has the authority to represent a service company in all matters relating to a service company registration under part 4732.####.

Subp. ##. Service Company. "Service company" means a person that is in the business

<u>of:</u>

- A. <u>selling, leasing, lending, transferring, demonstrating, installing, assembling,</u> repairing, replacing, storing, disabling, disposing and preventive maintenance of x-ray systems and x-ray imaging systems; or
- B. performing calibrations, equipment performance evaluations, radiation
 protection surveys, shielding plans of x-ray systems and x-ray imaging systems.

Subp. 72. Service provider. "Service provider" means a service company or individual that is registered with the commissioner to provide services under part 4732.####, subpart 4, for a registrant. A service provider includes a qualified medical physicist, a qualified expert, a service technician, or a vendor. Commented [JC(5]: States with same definitions as CRCPD (def. Subp. ##. Service technician. "Service technician" means a person who is employed by a

service company to:

- A. <u>install, assemble, calibrate, perform equipment performance evaluations and</u> preventive maintenance, replace, repair, or disable x-ray systems, x-ray imaging systems, and x-ray system or x-ray imaging system components;
- B. perform services under the general supervision of a qualified expert or a qualified medical physicist who assumes the responsibility for and signs or authorizes the final CT or interventional fluoroscopy equipment performance evaluation, shielding plan, or radiation protection survey report.

Subp. ##. Vendor. "Vendor" means a person who sells, leases, lends, transfers, disposes,

or demonstrates x-ray systems or x-ray imaging systems and x-ray system components.

Subp. 89. X-ray imaging system. "X-ray imaging system" means an assemblage of components for the reception of x-rays and the transformation, storage, and visual display of the resultant x-ray image that are designed and used for irradiation for the purpose of diagnosis or visualization. X-ray imaging systems do not include therapeutic imaging systems under chapter 4733.
