

At-Risk Population Planning Discussion Guide – Facilitator's Guide

Part 1: Facilitator's Guide

This document was created to serve as a discussion guide to drive conversations between healthcare coalition members, local public health, and other local partners, to support planning for at-risk populations with access and functional needs.

Facilitator Note: The following list of questions can be used during meetings with coalition members to guide discussions around at-risk population planning. Please see Part II of this guide for additional discussion questions. The questions are to support planning for at-risk populations with access and functional needs at the coalition level and are not entirely comprehensive of all at-risk population planning components.

 - o **Facilitator Note:** Additional questions that can be asked to guide discussion:
 - What are the biggest challenges in planning?
 - Where are the biggest gaps?
 - What work has been done so far?
 - What are the strengths in your planning?
- □ Do you know the demographics of at-risk individuals in your region?
 - Have you used the emPOWER Map or other mapping system to identify at-risk individuals in your region?
 - Facilitator Note: If the group is questioning who is considered an at-risk individual, refer them back to the PowerPoint slide that outlines which groups are considered at-risk populations according to The 2013 Pandemic and All-Hazards Preparedness Reauthorization Act.
 - Facilitator Note: According to the Assistant Secretary for Preparedness and Response (ASPR), It is important for coalitions to know the demographics of at-risk individuals in their region for the following reasons:
 - To help health officials anticipate and plan for the needs of electricity dependent community members who might be at risk and need community support during prolonged power outages.
 - To help first responders identify neighborhoods that may need rapid assistance
 - To help healthcare facilities anticipate a surge in demand for care

 - Facilitator Note: Additional question that can be asked to guide discussion:

- ☐ What role does each response partner (i.e. healthcare coalition, public health, emergency managers, EMS, human services) play when planning for at-risk populations?
 - Facilitator Note: Additional prompts/questions that can be asked to guide discussion:
 - Outline each partner's role to define who is responsible for what.
 - How or where are these roles/responsibilities documented?

Module 2: Transportation

Module 3: Medical Care/Medical Surge

- Have the health care facilities planned for surge due to an influx of patients that, though they may not be directly affected by the disaster, cannot be in a mass care setting and/or cannot go home?
 - Facilitator Note: Here are a list of ways that at-risk individuals may seek care at health care facility during an emergency:
 - Individuals who may not qualify for medical care but cannot return home or to a shelter
 - Individuals who are seeking electricity for medical devices
 - Individuals seeking dialysis or oxygen
 - Children separated from caregivers
 - Elderly who are too frail to be placed in a general needs shelter
