### Updates from the SEOC Hospital Data Team

### MDH MNTrac website updated with tons of info

As mentioned on our Tuesday session, we are updating our MNTrac webpage to include all pertinent information for you to have readily available: <https://www.health.state.mn.us/communities/ep/coalitions/mntrac.html>. You will find our data dictionary, FAQ, memos, and other pertinent info. We will inform you of any updates to the site as well as to the documents.

### News from TeleTracking/HHS

We have NOT heard back from TeleTracking regarding an update import template. At this point we are all still using the current template. **Please continue with the template we have on MNTrac (dated 7/28).**

### PPE Reporting Frequency Change

According to the newly [updated guidance from HHS dated July 29, 2020](#) data elements 26 – 32 (all PPE elements) are only required to be submitted three times a week (Monday, Wednesday, and Friday).

**Effective Monday, August 10, 2020, hospitals can begin to submit their PPE data three times a week.** Please note that if you have an established and streamlined process in place to capture this information and do not wish to disrupt the process – stay the course. For our state reporting purposes, we will use data submitted on Mondays, Wednesdays, and Fridays.

### Upcoming changes – hot off the press!

Our team found “[Pre-Release Information](#)” posted on TeleTracking regarding changes being released on Thursday August 13<sup>th</sup> at 7am EST. We are in the process of actively awaiting additional feedback on these changes. As soon as we get more information we will update you all. Our vendor, ImageTrend, has also been informed and they are awaiting additional information as well in efforts to move forward with development and provide an updated template.
