

# Capacity Strengthening Initiative Grant Review Process Summary

#### MEMO TO APPLICANTS AND PARTNERS | MAY 2024

The Minnesota Department of Health's Center for Health Equity previously released a request for proposals (RFP) for the Capacity Strengthening Initiative (CSI), a grant program established to empower and uplift the ability of community organizations to receive state funding that is focused on improving the health and well-being of Minnesotans.

The initiative focuses on helping community and faith-based organizations that serve people of color, American Indians, LGBTQIA+ communities, and people with disabilities.

The grant application period closed on November 20, 2023. The community review process began in 2024. The process engaged more than 80 community members and partners in the review of applications. The Commissioner of Health made final funding decisions in February 2024 based on community recommendations, then all applicants were notified.

# **Funding Requested**

The total funding requested by all applicants was **\$27.35M**. Total funding available is **\$1.832M**, which consists of general funds reserved for Capacity Strengthening Initiatives (CSI) to better equip and prepare community-based organizations for success in procuring grants and contracts.

### **Applicants**

MDH received **300 applications**. 291 applications were deemed eligible and complete and were reviewed by the community review committee.

#### **Grant Objectives Areas**




Figure 1: Selected Grant Objectives

The graph below (Figure 1) shows the various priority grant objectives of focus among the applicants. Many applicants indicated that they would address more than one priority.

#### Race and Ethnicity




Figure 2: Racial/Ethnic Groups Organizations Serve

Based on applicants' descriptions of the primary racial/ethnic groups to be served by their proposal, the 300 applicants were categorized into seven categories in order to assess racial/ethnic groups: African American, African Immigrants, American Indian, Asian/Pacific Islander, and Hispanic/Latino/Latina/Latine, LGBTQIA+, and people living with disabilities. The graph below (Figure 2) shows the breadth of racial/ethnic groups to be served among applicants. Many applicants indicated that they would serve more than one racial/ethnic group.

#### **Review Process**

#### **Community Review Committee**

MDH received more than 86 applications to participate in the review process for roles as a reviewer, facilitator, or note taker. MDH selected and trained around 80 reviewers, facilitators, and note takers. Below is a summary of demographic information for the reviewers who participated in the review process. Note that people hold - and reported - intersecting identities.

- 55% of reviewers identify as people of color and/or American Indians.
- 20% of reviewers identify as LGBTQI+ (lesbian, gay, bisexual, trans, queer, intersex, plus).
- 21% of reviewers identify as having a disability.

#### **Review Team and Scores**

Reviewers were divided into 20 review teams. Each of the twenty teams reviewed between fourteen to fifteen applications. In addition to offering funding recommendation for each application, reviewers individually scored each application out of a total 100 possible points. Each applicant's final score was based on the **average score** of all team members who reviewed the application. Of the eligible applicants:

- 27 applications received an average team score of ≥ 90 (9%).
- 104 applications received an average team score between 80-89.9 (36%).
- 160 applications received an average team score of ≤ 79.9 (55%).

Finally, MDH balanced the review teams' recommendations with other factors including, but not limited to: Review team scores, geographic distribution of services, representativeness of populations served, and total funding available.
