*The duties of the Maternal and Child Health (MCH) Advisory Task Force are to review and report on the health care needs of mothers and children; review and report on MCH services provided to mothers and children; review and report to the commissioner program guidelines and criteria essential to providing an effective MCH program to low-income populations and high risk persons; make recommendations to the commissioner for the use of other federal and state funds available to meet MCH needs; make recommendations to the commissioner of health on priorities for funding MCH services (prenatal, delivery, postpartum; comprehensive health care; adolescent health; family planning; preventative dental; services for children with special health care needs; and any other services that promote the health of mothers and children); and establish in consultation with the commissioner statewide outcomes that will improve the health status of mothers and children.
