

Formula Issued – Local Agency Breakdown & State Summary

FOOD & FORMULA (11.24.20)

Report Overview

This report replaces, and combines, the *Formula Issued – Local Agency Breakdown* and *Formula Issued – State Summary* reports that were run at the same time End-of-Month was run and that were previously posted in the AGENCY EOM >> [Year] >> [Year Month] >> Minnesota Reports folder.

It provides a list of formulas issued by each agency, as well as statewide, and the number of participants who were issued each formula. An OPTIONAL input control allows the output in the Agency tab to be filtered by Agency ID.

Some Uses Include:

- Comparison of State and Local Agency totals for issuance of formula.
- Obtain count of participants receiving a specific type of formula or formulas.
- Identify which agencies are issued a specific type of formula.

Notes

- Counts will be close but will NOT exactly match reports posted to the AGENCY EOM folder. These counts are not static. They are based on benefit issuance and **not** the end-of-month caseload count. Although the report may have seemed static when posted to the AGENCY EOM; it was only because they were run only once around the 15th of the each month.
- Counts are not unduplicated.
 - If a participant was issued formula by more than one agency for the specified participation month, the participant is counted once for each agency.
 - If a participant was issued more than one kind of formula, the participant is counted once for each kind of formula issued.
- The Agency is based on where the benefits were issued.
- This report uses Report Input controls to allow the report user to specify Agency IDs and filter the output in Tab 1 – Agency. (An Input Controls training module is available on the Infoview Training Modules page of the MDH WIC Website.)

- After entering PROMPT information and running the report, click the Input Controls icon.
- The default input control is to run the report for all agencies.
- Remove the checkmark from the Select All checkbox and select one or more Agency IDs to filter the report output in Tab 1 – Agency ID.
- The report output has been formatted to export to an 8.5 x 11 Portrait PDF. It can also be exported to Excel (NOTE: the margins will need to be adjusted and the headers/footers may not display).
