Technician Hours Log Requirements

The log must be typed and use hours and minutes (example: 2 hours and 30 minutes, not 2.5 hours)

Minnesota Statute 146B.03, subdivision 12, requires the following minimum supervised experience for licensure:

1. A tattoo technician must provide proof of completing 200 hours of supervised tattooing.
2. A body piercing technician must provide proof of completing 250 piercings under direct supervision and 250 piercings under indirect supervision.
3. A dual technician must provide proof of completing 200 hours of supervised tattooing, as well as complete 250 piercings under direct supervision and 250 piercings under indirect supervision.

The hours log must include a list of each licensed technician who provided the required supervision.

You may make copies of this sample log to document the required tattooing hours or number of piercings completed under supervision.
