(2) No facility or building on a campus may provide assisted living services until obtaining the required license under paragraphs (c) to (e).? (b)?The licensee is legally responsible for the management, control, and operation of the facility, regardless of the existence of a management agreement or subcontract. Nothing in this chapter shall in any way affect the rights and remedies available under other law? (c) Upon approving an application for an assisted living facility license, the commissioner shall issue a single license for each building that is operated by the licensee as an assisted living facility and is located at a separate address, except as provided under paragraph (d) or (e).? (d) Upon approving an application for an assisted living facility license, the commissioner may issue a single license for two or more buildings on a campus that are operated by the same licensee as an assisted living facility. An assisted living facility license for a campus must identify the address and licensed resident capacity of each building located on the campus in which assisted living services are provided? | 0 100 | <p>Continued From page 2</p> <p>living facility with dementia care.</p> <p>This MN Requirement is not met as evidenced by: Based on observation, interview, and document review the facility operated under an expired Assisted Living license while providing service to two residents and advertised as an assisted living facility.</p> <p>This practice resulted in a level two violation (a violation that did not harm a client's health or safety but had the potential to have harmed a client's health or safety, but was not likely to cause serious injury, impairment, or death), and was issued at a widespread scope (when problems are pervasive or represent a systemic failure that has affected or has potential to affect a large portion or all of the clients).</p> <p>Findings Include:</p> <p>On October 10, 2022, an investigator with the Minnesota Department of Health (MDH) visited Minnesota Group Home at 6322 Pleasant Avenue South in Richfield. The facility was operational and providing two residents with 24/7 assisted living services.
