



Advisory Council meetings are held at least quarterly to conduct the business of the Council. Meetings are open to the public and public comments in the Webex chat are reviewed.






Insight 2 Action

- The mission is to enhance compliance and improve health outcomes through leveraging data-driven insights, stakeholder collaboration, and systemic analysis.



Insight 2 Action

Nursing Home Areas of Study

- Influenza and pneumococcal immunization exploring barriers to compliance with CMS requirements.
- Personal protective equipment (PPE) exploring barriers to appropriate use of PPE.
- Cleaning and disinfection exploring barriers related to shared equipment.

Next Step

- Focus Groups will be starting in April 2025 for Nursing Home Providers. Assisted Living Providers participation will begin in Fall of 2025.
- Focus groups contain 6 to 8 participants per session to share perspectives on a specific topic and last one hour with an optional follow up if needed.
- Interactive discussion to explore shared experiences and behaviors
